#### SASKATCHEWAN REGULATIONS 13/2019

### The Traffic Safety Act

Section 287

Order in Council 59/2019, dated March 6, 2019

(Filed March 7, 2019)

#### Title

1 These regulations may be cited as *The Driver Training Amendment Regulations*, 2019.

#### RRS c T-18.1 Reg 9 amended

2 The Driver Training Regulations, 2011 are amended in the manner set forth in these regulations.

#### New section 4

3 Section 4 is repealed and the following substituted:

#### "Restrictions

- 4 No person shall provide driving instruction in a vehicle unless that person:
  - (a) holds a class 1, 2, 3 or 4 driver's licence, if that person is providing instruction to a student who is seeking to obtain a class 4 or 5 driver's licence;
  - (b) holds a class 1 driver's licence with an 'A' endorsement, if that person is providing instruction to a student who is seeking a class 1, 2 or 3 driver's licence;
  - (c) holds an 'M' endorsement, if that person is providing instruction to a student who is seeking to obtain an endorsement to operate a motorcycle; and
  - (d) holds an 'S' endorsement, if that person is providing instruction to a student who is seeking to obtain an endorsement to operate a school bus".

#### Section 5 amended

#### 4(1) The following subclause is added after subclause 5(1)(b)(i):

- "(i.1) if the administrator determines that a vulnerable sector search is necessary, a vulnerable sector search respecting the applicant that is signed by a peace officer or an officer of the R.C.M.P. detachment or the Town Constable of the municipality in which the applicant carries on business".
- (2) Subsection 5(5) is amended by striking out "60" and substituting "90".

#### Section 10 amended

#### 5 The following subsection is added after subsection 10(3):

"(3.1) The administrator shall not issue a driver training school certificate to an applicant unless the applicant can verify that the applicant employs or has contracted with at least one certified driver instructor able to provide instruction for the driver training school at the time of the application".

#### Section 13 amended

#### 6(1) Subsection 13(1) is amended:

#### (a) by repealing clause (a) and substituting the following:

"(a) if the completion of the student's driver training is not recorded by the school on the administrator's electronic driver training application, a copy of the student driver education certificate number"; and

#### (b) by repealing clause (j) and substituting the following:

- "(j) if the student is receiving driving instruction for a commercial vehicle:
  - (i) the log books required to be maintained during training;
  - (ii) if applicable, the dates and hours of in-yard instruction;
  - (iii) all Schedule 1 inspection reports as set out in *The Trip Inspection Regulations*; and
  - (iv) the student's progress reports and evaluations".
- (2) Subsection 13(2) is repealed.
- (3) Subsection 13(3) is amended by striking out "subsections (1) and (2)" and substituting "subsection (1)".

#### New section 19

#### 7 Section 19 is repealed and the following substituted:

#### "Standards for class 1 vehicle

- **19**(1) In addition to the requirements set out in section 17, every class 1 motor vehicle used in driver training by a driver instructor to train a student must:
  - (a) have a registered gross vehicle weight of 22,000 kilograms;
  - (b) be the object of a valid inspection certificate as required pursuant to *The Vehicle Inspection Regulations*, 2013;
  - (c) have special rear-view mirrors firmly affixed to the vehicle to allow a driver instructor a clear and unobstructed view of the highway to the rear of the vehicle and along both sides of the vehicle; and
  - (d) a sign at the rear of the vehicle that is conspicuously and clearly visible from a distance of 60 metres and that contains either the words 'Student Driver' or 'Driver Training' in letters not less than 20.5 centimetres in height.
- (2) In addition to the requirements set out in subsection (1), if any class 1 driver training is conducted with a trailer, the trailer must also be the object of a valid inspection certificate as required pursuant to *The Vehicle Inspection Regulations*, 2013".

#### New section 21.1

#### 8 The following section is added after section 21:

#### "Facility requirement for class 1 driver instruction

**21.1** A class 1 driver training school must have a facility that is approved by the administrator".

**9** These regulations come into force on the day on which they are filed with the Registrar of Regulations.

### The Traffic Safety Act

Section 287

Order in Council 60/2019, dated March 6, 2019

(Filed March 7, 2019)

#### Title

1 These regulations may be cited as *The Driver Licensing and Suspension* (Class 1 Driver's Licence) Amendment Regulations, 2019.

#### RRS c T-18.1 Reg 2, section 11 amended

- 2 Section 11 of *The Driver Licensing and Suspension Regulations*, 2006 is amended by adding the following subsection after subsection (9):
- "(9.1) No person is eligible to be issued a class 1 driver's licence unless that person has successfully completed a class 1 driver training program approved by the administrator".

#### Transitional

3 Notwithstanding subsection 11(9.1), a person who holds a class 1 driver's licence before March 15, 2019 is not required to complete a class 1 driver training program.

#### Coming into force

4 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

2 The Northern Municipalities Regulations are amended in the manner set forth in these regulations.

- 3 Subclause 63(b)(iii) is repealed and the following substituted:
  - "(iii) in the case of the Northern Capital Grants Program, any costs incurred before October 1, 2018 or after September 30, 2023 except any costs that the minister may allow that were incurred before October 1, 2018 and with respect to which no other claim has been made under any Northern Capital Grants Program".

#### Section 66 amended

- 4(1) Subsection 66(1) is repealed and the following substituted:
- "(1) The Northern Capital Grants program is continued for the purpose of assisting eligible municipalities to acquire, construct and equip capital works during the period commencing on October 1, 2018 and ending on September 30, 2023".

- "(4) The maximum gross weight on a tire that has a width of 445 millimetres or greater is 10 kilograms per millimetre of tire width, up to a maximum of:
  - (a) 4550 kilograms on the highways or portions of primary highways listed in Appendix D;
  - (b) 3850 kilograms on provincial highways that are the subject of a minister's order made pursuant to clause 35.1(1)(d) of the Act that authorizes a person to operate a vehicle or class of vehicles on those highways specified in the order during the effective period of the order at the weights set for primary highways by these regulations; and
  - (c) 3850 kilograms on any other highways not mentioned in clauses (a) and (b) during the winter weights season".
