Overview of Travel and Objectives

The Council of Ministers of Education Canada (CMEC) and the Advisory Committee of Deputy Ministers of Education (ACDME) meetings were held in Victoria in July 2019. The annual meetings gather the Federal, Provincial and Territorial Ministers and Deputy Ministers of Education across Canada to discuss shared priorities in the K-12 and post-secondary education sector.

The agenda focused on Indigenous education, post-secondary education sustainability and outcomes, technology in elementary-secondary education, international education and the future of education and work.

Travel Activity:

The delegation from Saskatchewan engaged in a number of activities and a summary of the meetings are listed below.

ACDME Meeting:

- Deputy Ministers and officials engaged with an expert panel on the future of education and work, participated in a working session on current federal initiatives related to education and training, and discussed the current state of education and the future directions of technology in elementary-secondary education.
- Saskatchewan led the CMEC International Education and Engagement Strategy discussion that was focused on identifying challenges and opportunities in international education.

CMEC Meeting:

- Ministers and Deputy Ministers engaged in a roundtable discussion on revitalizing Indigenous languages, listened to a student panel, and received a presentation from Ontario and Nova Scotia that highlighted plans to improve post-secondary sustainability and outcomes.
- Ministers approved the Indigenous Education Plan and participated in a session on reimagining education that focused on the future of education and work.
- Ministers approved the CMEC Post-Secondary Education Strategy, participated in discussions to finalize the Protocol for Agreements for Minority-Language Education and Second-Language Instruction and discussed CMEC's business and provincial/territorial education priorities for the next year.
- This CMEC meeting marked the end of British Columbia's term as Chair of CMEC. The new Chair of CMEC is the Northwest Territories while the Vice-Chair is Saskatchewan. Saskatchewan will chair the ACDME meetings for the next two years.
