CHAPTER E-9

An Act respecting Employment Agencies

Short title

1 This Act may be cited as *The Employment Agencies Act*.

Interpretation

1.1 In this Act, “**minister**” means the member of the Executive Council to whom for the time being the administration of this Act is assigned.

Fee prohibited

2 No person, firm, corporation or association shall collect or receive, directly or indirectly, any fee or compensation for sending or persuading, enticing, inducing, procuring or causing to be sent from or to any place within the province, to or from any place outside the province, or between any two places within the province, any person seeking employment, or for giving or furnishing information regarding employers seeking workers or workers seeking employment.

Penalty

3 A person violating section 2 is guilty of an offence and liable on summary conviction before a provincial magistrate or two or more justices of the peace to a fine of not less than \$10 nor more than \$25.

Exception

4 Sections 2 and 3 do not apply to persons whose agency is confined to supplying positions in connection with educational institutions.

Use of word “Saskatchewan”

5 No person or firm acting as or operating an employment agency shall use the word “Saskatchewan” as part of the name of the agency.

Municipal employment agencies

6 Any town, village, northern municipality or rural municipality, in which there is no government employment office, may establish an employment office and may charge to employers availing themselves of its services such fees as may be fixed by bylaw.

Reports to department

7 The clerk or secretary treasurer of a municipality that establishes an employment office under section 6 shall forthwith notify the minister and shall furnish such information and make such reports to the department over which the minister presides as the minister may require.
