Overview of Travel and Objectives

The purpose of this trip was to attend the 2019 Tri-National Agricultural Accord which is an annual meeting of Ministers, Commissioners, Secretaries and Directors of Agriculture and senior officials from the Canadian provinces, United States and Mexican states.

Accord meetings are one of the few opportunities where Agriculture Ministers and senior officials from Canada, the United States and Mexico have an opportunity to meet with counterparts and senior federal officials to discuss agricultural trade policy issues.

This year's Accord took on added significance due to the current global trade challenges including the United States-Mexico-Canada Agreement (USMCA). Discussions highlighted that USMCA implementation will maintain positive trade conditions while supporting innovation and agriculture investment in all three countries. Recognizing the importance of trade and fostering cooperation among these three countries, delegates acknowledged Mexico's leadership in being the first party to ratify to USMCA. Delegates called for the federal governments in the United States and Canada to proceed with ratification of the agreement as soon as possible.

With heightened global concerns relating to agricultural trade, including Canada's canola exports, it is important that Saskatchewan be represented to ensure the Canadian delegation maintains strength in its position in these matters, and to meet and discuss trade issues and areas of collaboration with several state governments and industry groups.

Travel Activity:

The Accord was an opportunity to meet and discuss trade issues and areas of collaboration with several provinces and state governments.

The following meetings and discussions occurred at the Accord;

- Participated in Canada-U.S. bilateral meeting;
- Co-chaired and presented at the Canada-Mexico bilateral meeting;
- Attended trilateral meetings focused on collaboration on animal diseases, particularly African Swine Fever, and the benefits of trade;
- Participated in Prairie Ministers' meeting;
- Met with the Ontario Minister of Agriculture; and,
- Met with Doug Chorney of the Canadian Grain Commission.
