[section 53]**RESTRUCTURING OF THE VILLAGE OF KEELER**

Pursuant to section 53 of *The Municipalities Act*, the Village of Keeler has applied to restructure to be included in the Rural Municipality of Marquis No. 191 as a designated Special Service Area.

**IT IS HEREBY ORDERED THAT:**

**1** The Village of Keeler is restructured by inclusion of the Village of Keeler within the Rural Municipality of Marquis No. 191.

**2** The former Village of Keeler is designated as a Special Service Area for the purpose of the assignment of different tax rates, application of different tax tools and provision of different service levels.

**3** The boundary of the designated Special Service Area is consistent with the boundary of the former Village of Keeler and is described as:

the south-west quarter and legal subdivisions 11 and 12 of Section 7, Township 20, Range 28, West of the Second Meridian, in the Province of Saskatchewan.

**4** The Rural Municipality of Marquis No. 191 shall allocate to separate general ledger accounts all revenues collected for and on behalf of the Special Service Area and all expenses paid for and on behalf of the Special Service Area.

**5** A statement of revenues and expenditures of the Special Service Area shall be presented to council annually and any additional time(s) requested by council.

**6** The terms and conditions of the restructuring agreement entered into by the Village of Keeler and the Rural Municipality of Marquis No. 191 are confirmed as follows:

**Opening Statements**

(1) This agreement has been entered into by the Village of Keeler (Village) and the Rural Municipality of Marquis No. 191 (RM) for the purpose of the inclusion.

**Restructuring Principles**

(2) All parties agree to respectfully work together to negotiate sustainable, long-range mutual benefits to their citizens now and in the future.

(3) Where one municipality has concerns on a matter, the other municipality will negotiate in good faith and work cooperatively toward addressing the concern in this agreement.

**Establishment of Special Service Area**

(4) The lands within the former Village shall be designated as a Special Service Area for the purposes of assigning different tax rates and/or the application of tax tools and providing different service levels.

(5) The designated Special Service Area shall be within the boundaries of the former Village.

**Governance**

(6) A municipal council consisting of a reeve and councillors will govern the RM.

(7) All bylaws and resolutions in force in the Village continue in force for one year after the date of inclusion or until they are sooner repealed or others are made in their place.

**Disposition Of Assets**

(8) The assets and liabilities of the Village shall become the assets and liabilities of the RM upon inclusion of the Village.

(9) Cash assets remaining subsequent to settlement of the Village assets and liabilities will be set aside for provision of services and/or benefits within the former Village.

(10) All grants received by the RM in recognition of the former Village will be set aside for provision of services and/or benefits within the former Village.

#### **Service Delivery**

(11) The RM will ensure that fire protection services are inclusive and consistent with fire protection service agreements currently established by the municipality.

(12) The RM of Marquis No. 191 will contract Adam Keeler to oversee the operation of the Keeler well, including daily and monthly testing, and to ensure these operations are performed according to current government regulations. The costs for water delivery will be passed on to ratepayers of the Special Service Area over and above taxes.

(13) The RM of Marquis No. 191 will contract garbage pick-up services for the former Village of Keeler residents and these services will be paid for by the ratepayers of the Special Service Area.

(14) The Keeler well site will be subdivided and a new parcel will be created in the name of the RM of Marquis No. 191 and costs relating to this subdivision will be paid for by the Special Service Area.

#### **Integration of Administration**

(15) The administrator for the Village will not continue on as a contract employee of the RM. Any services required of Rebecca Colenutt to finalize the administration of restructuring will be paid for by the Special Service Area at a cost of \$20/hour.

#### **Amendments**

(16) This agreement may be amended:

(a) by the agreement of the councils which are signatories to the agreement, prior to the application being forwarded to the Minister for approval; and/or

(b) by the council of the RM after a two-year period from the effective date of the Minister's Order, when an amendment is in the best interest of the ratepayers of the former Village and the RM.

The Restructuring Agreement dated October 19, 2020 is null and void and is replaced by this one.

#### **Effective Date**

(17) This agreement will come into effect on the date of inclusion as set out in the Minister's Order.

**7** The restructuring will take effect on December 31, 2020.

**8** The imposition of special levies is authorized on affected properties for a period not greater than ten years or in the case of retiring a debt of the Village of Keeler not greater than the term of the debt, for the following purposes: renewing municipal infrastructure; remedying and reclaiming contaminated sites; and settling any liabilities.

**9** Diana Lee of Regina, Saskatchewan, is appointed to adjust and settle the assets and liabilities of the Village of Keeler including:

(i) the sale of, the disposition of and conversion into money of sufficient assets to satisfy the liabilities of the Village of Keeler and to pay the remuneration of the person appointed by this Order; and

(ii) the ability to assess, levy, collect and enforce payment of any amount required to satisfy the liabilities of the Village of Keeler, including all associated expenses and remuneration of the person appointed by this Order, when the realizable assets do not satisfy the liabilities pursuant to subsection 63(4) of *The Municipalities Act*.

10 Remuneration for settling the assets and liabilities shall be paid to Diana Lee at a rate of \$65.00 per hour of work, in addition to 45.35 cents/travelled kilometre and reimbursement of related miscellaneous expenses.

IT IS HEREBY ORDERED THAT:

1 The Village of Margo is restructured through the inclusion of the Village of Margo within the Rural Municipality of Sasman No. 336.

2 The former Village of Margo is designated as a Special Service Area for the purpose of assigning different tax rates, applying different tax tools and providing different service levels within the Rural Municipality of Sasman No. 336.

3 The boundary of the designated Special Service Area is consistent with the former Village of Margo boundaries and is described as lying within Township 33, Range 10, West of the Second Meridian and described as:

(a) The following portions of the north-east quarter of Section 10 as shown on Registered Plan Nos. BG1252 and BJ3900;

(b) the following portions of Section 15:

(i) the south-east quarter; and

(ii) that portion of the south-west quarter commencing at the intersection of the northerly limit of registered roadway Plan No. 81HO1359 and the eastern boundary of said quarter section, thence northerly along the eastern boundary Eight Hundred and Eighty-five and Four Hundred and Fifty-six Thousandths (885.456) feet, thence westerly and parallel to the northerly limit of said roadway plan Two Hundred and Ninety-five and Fifteen Hundredths (295.15) feet, thence southerly and parallel to the eastern boundary to the northerly limit of said roadway plan, thence east along the northerly limit to the point of commencement. (5) The RM shall allocate all revenues collected from and on behalf of the special service area ledger accounts and all expenses of the Special Service Area shall be allocated to and paid from the special service area ledger accounts.

(6) A statement of revenues and expenditures of the special service area to be presented to council annually and any additional time(s) requested by council.

(7) The designated Special Service Area shall be within the boundaries of the former Village.

**Governance**

(8) A municipal council consisting of a reeve and six (6) councillors will govern the Rural Municipality of Sasman No. 336.

(9) The RM agrees to establish a committee, namely the Margo Community Advisory Committee, and appoint at least three representatives annually. The sole purpose of this committee is to provide advice to council on matters relating to the Special Service Area designated above. A representative from the Margo Community Advisory Committee will be present at the RM of Sasman No. 336's regular scheduled meetings on a bi-annual basis to discuss Special Service Area matters. The RM will pay remuneration to committee members from the Special Service Area revenue and may amend, add or modify any function of this committee as deemed necessary by resolution.

(10) All bylaws and resolutions in force in the Village continue in force for one year after the date of inclusion or until they are sooner repealed or others are made in their place.

**Disposition Of Assets**

(11) The assets and liabilities of the Village shall become the assets and liabilities of the RM upon inclusion of the Village.

(12) Cash assets remaining subsequent to settlement of the Village assets and liabilities will be set aside for provision of services and/or benefits within the former Village.

13. All grants received by the RM in recognition of the former Village will be set aside for provision of services and/or benefits within the former Village.

**Service Delivery**

(14) The RM will ensure that fire protection services are inclusive and consistent with fire protection service agreements currently established by the municipality.

(15) The RM will maintain the streets by way of grading gravel in the spring, summer and fall months and will provide and manage snow removal during winter months consistent with current practices.

(16) The RM will continue to employ Mr. John Stewart for general maintenance, water treatment operations and garbage collection within the boundaries of the former Village of Margo consistent with current arrangements and may amend or terminate the contract as deemed necessary.

(17) The RM will contract Mr. Scott Roberg to maintain the grounds of the Margo cemetery, and may amend or terminate the contract as deemed necessary.

(18) The transfer station is currently owned and operated by the Village of Margo and this service shall continue to be assigned to the Special Service Area of Margo. All revenues and expenditures associated with the transfer station shall be allocated to the Special Service Area accounts.

**Integration Of Administration**

(19) The current administrator for the Village of Margo will be employed by the RM of Sasman No. 336 as administrative assistant and the RM may modify and make changes or terminate this employment as necessary.

(20) The RM will open the former village office of the Special Service Area in Margo one day a week and provide personnel for that time, and may modify and make arrangements as necessary.

**Amendments**

- (a) by the agreement of the councils which are signatories to the agreement, prior to the application being forwarded to the Minister for approval; and/or
