MINISTER'S ORDER/ARRÊTÉ MINISTÉRIEL

The Municipalities Act [subclause 61(2)(c)(iii)]

RESTRUCTURING THE VILLAGE OF PLUNKETT

Pursuant to subclause 61(2)(c)(iii) of *The Municipalities Act* (Act), the minister may, by Order, restructure municipalities by providing for the inclusion of a municipality in any other municipality where the minister considers it to be in the public interest to do so.

IT IS HEREBY ORDERED THAT:

- The Village of Plunkett (Village) shall be restructured by inclusion into the Rural Municipality of Viscount No. 341 (RM) and shall be designated as a Special Service Area (SSA) for the purpose of assigning different tax rates, applying different tax tools, and providing different service levels.
- The boundary of the designated SSA is consistent with the boundary of the Village and is described as:
 Lying within the north-west quarter of Section 11, Township 34, Range 25, West of the Second Meridian, in the Province of Saskatchewan.
- The RM shall allocate to separate general ledger accounts all revenues collected for and on behalf of the SSA and all expenses paid for and on behalf of the SSA.
- A statement of revenues and expenditures of the SSA shall be presented to the council of the RM annually and at any additional time(s) requested by council.
- The terms and conditions of the original restructuring agreement entered into by the Village and the RM, attached as Appendix A, are approved.
- The restructuring will take effect on April 1, 2022.

IT IS FURTHER ORDERED THAT:

7 DIANA LEE of Regina, Saskatchewan, be appointed as a transition official to work with the Village administrator to facilitate the transition of the Village into the RM in accordance with the requirements of the Ministry of Government Relations (Ministry) and this Order including:

- the authority to access all municipal property, including any private premises where municipal records are located or stored, for the purpose of accessing and reviewing municipal records. "Municipal records" include any written, recorded or electronic records;

- (b) the authority to remove municipal records from any place where they are located or stored for the purpose of reviewing the records;
- (c) the authority to prepare or assist in the preparation of all documents and accounts as outlined by the ministry or required for the final audit on behalf of the Village;
- (d) the authority to contact any ministry, crown, agency, business, or other person to request or provide information; and
- (e) the authority to sign documents and approve payments if the administrator is unable to act.

8 The appointment of Diana Lee is in effect for the period between the signing of this Order and no later than 30 days after the effective date of the restructuring of the Village.

9 Remuneration for Diana Lee will be paid at a rate of \$65.00 per hour of work, in addition to 48.50 cents per kilometre and reimbursement of related miscellaneous expenses.

10 Remuneration for Diana Lee shall be paid by the RM on approval of the ministry's supervising municipal advisor, after the effective date of the restructuring. The RM shall expense any payments to Diana Lee to the SSA ledger accounts.

IT IS FURTHER ORDERED THAT:

11 WAYNE ZERFF of Regina, Saskatchewan, be appointed to adjust and settle the assets and liabilities of the Village in accordance with legislation, requirements of the ministry, the restructuring agreement, and this Order, including:

- (a) the allocation of any grants, surplus funds, and reserves; and
- (b) the manner of dealing with liabilities through:
 - (i) the sale of, the disposition of and conversion into money of sufficient assets to satisfy the liabilities of the Village and pay the remuneration of the persons appointed by this Order;
 - (ii) the ability to assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the municipality, including all associated expenses and the remuneration of the persons appointed by this Order, when the realizable assets do not satisfy the liabilities pursuant to 63(4) of the Act; and
 - (iii) the authority to access the Village funds and bank accounts after the effective date of restructuring, transfer funds to the RM and direct the RM regarding the intended use of the funds including such uses as SSA reserve or revenue accounts.

12 The appointment of Wayne Zerff is in effect for the period between the effective date of the restructuring and the date the final report to the minister has been submitted to the ministry.

13 Remuneration for Wayne Zerff will be paid at a rate of \$70.00 per hour of work, in addition to 48.50 cents per kilometre and reimbursement of related miscellaneous expenses.

14 Remuneration for Wayne Zerff shall be paid by the RM on approval of the ministry's supervising municipal advisor, after the effective date of the restructuring. The RM shall expense any payment to Wayne Zerff to the SSA ledger accounts

APPENDIX "A"

RESTRUCTURING AGREEMENT

*between the Rural Municipality of Viscount No. 341 (RM)
and the
Village of Plunkett (Village)*

1 PURPOSE

1.1 This agreement has been negotiated between the Village and the RM for the purpose of inclusion of the Village within the RM.

2 RE-STRUCTURING PRINCIPLES

2.1 The representatives of the RM and the Village will work together respectfully and cooperatively to negotiate a sustainable, long-range plan that results in mutual benefits to the citizens of the municipalities now and into the future.

2.2 Where one (1) municipality has concerns on a matter, the other municipality will negotiate in good faith and work cooperatively toward addressing the concerns for purposes of creating a solid and satisfactory agreement.

3 ESTABLISHMENT OF SPECIAL SERVICE AREA

3.1 The lands within the former Village shall be designated as a Special Service Area (SSA) for the purposes of assigning different tax rates and/or the application of tax tools and providing differing service levels from other areas in the RM.

3.2 The designated SSA shall be within the boundaries of the former Village.

4 GOVERNANCE

4.1 A municipal Council consisting of a Reeve and six (6) Councillors will govern the RM.

4.2 The Council of the RM agrees to establish a Committee, being the Plunkett Special Service Area (SSA) Advisory Committee.

4.2.1 The RM shall appoint a minimum of two (2) representatives from the community of Plunkett to this Committee annually.

4.2.2 The sole purpose of this Committee is to provide advice to Council on matters relating to the SSA designated above.

4.2.3 At least one (1) member of the Committee shall attend the RM's regularly scheduled Council meetings on a quarterly basis, unless attendance becomes required more often, as a delegate to discuss SSA matters.

4.2.4 The RM shall pay remuneration to the Plunkett SSA Advisory Committee from the SSA revenue in the amount of \$80.00 per month per member.

4.2.5 A statement of revenues and expenditures incurred by the SSA shall be presented to the Plunkett SSA Advisory Committee on a quarterly basis.

4.2.6 The RM may by resolution amend, add, or modify any function of this Committee as deemed necessary at any point after the Committee has been in place for at least two (2) fiscal years.

4.2.7 In the event that the RM is unable to acquire interest from the individuals in Plunkett to serve on the Plunkett Special Service Area (SSA) Advisory Committee, the RM shall retain the right to eliminate the need for this Advisory Committee.

4.3 All bylaws and resolutions in force in the Village will continue to be in force for one (1) fiscal year after the date of inclusion or until they are sooner repealed and others are made in their place.

5 DISPOSITION OF ASSETS AND LIABILITIES

5.1 The assets and liabilities of the Village shall become the assets and liabilities of the RM upon inclusion of the Village.

5.2 Cash assets remaining subsequent to settlement of the Village's liabilities will be set up in separate accounts in the RM's financial records for provision of services and/or improvements within the former Village.

5.3 All grants received by the RM in recognition of the former Village will be set up in separate accounts in the RM's financial records for provision of services and/or improvements within the former Village.

6 SERVICE DELIVERY

6.1 GENERAL

6.1.1 All revenues associated with service delivery within the SSA shall be allocated to the SSA accounts in the RM's financial records.

6.1.2 All expenditures associated with service delivery within SSA shall be allocated to the SSA accounts in the RM's financial records.

6.2 WATER AND SEWER

6.2.1 The RM will proceed with the installation of a reverse osmosis water treatment system, as was committed to by the former Village Council, in order to bring the quality of water distributed to the residents of Plunkett to a standard that is acceptable to Saskatchewan Water Security Agency.

6.2.1.1 The installation of the reverse osmosis water treatment system will be funded using the committed funding through the Municipal Economic Enhancement Program (MEEP), the committed funding through the Canada Community-Building Fund (formerly Gas Tax Program), and municipal borrowing attributed to a Local Improvement project to be assessed to each legal land location within the former Village.

6.2.2 The RM will secure the services of an operator for the water treatment plant and water distribution system who is qualified to the standards required by provincial regulations.

6.2.3 The operator of the water treatment plant will be retained on a contract for services basis unless that individual assumes more extensive duties relating to the maintenance of the community of Plunkett.

6.2.4 The well and well-site shall be maintained at the same level of service from that which exists at the time of inclusion of the Village within the RM in order to attain compliance with the requirements of Saskatchewan Water Security Agency.

6.2.5 The water distribution system shall be maintained at the same level of service that exists at the time of inclusion of the Village within the RM.

6.2.6 The sewer system shall be maintained at the same level of service that exists at the time of inclusion of the Village within the RM.

6.2.7 The sewage lagoon shall be maintained exclusively for the use of the residents of Plunkett only.

6.3 PLUNKETT COMMUNITY HALL

6.3.1 The Council of the RM agrees to continue to operate the Plunkett Community Hall by way of a Board, being the Plunkett Recreation Board, that will oversee the operation of the Community Hall.

6.3.1.1 The RM shall adopt a Plunkett Recreation Board bylaw which will direct the operation of the Plunkett Community Hall into the future.

6.3.1.2 The sole purpose of this Board is to provide advice to Council on matters relating to the Plunkett Community Hall.

6.3.1.3 The Board shall conduct itself in the same fashion as was expected of those associated with the Plunkett Community Hall in the past.

6.3.1.4 The RM may by bylaw amend, add, or modify any function of the Board as deemed necessary.

6.4 SOLID WASTE DISPOSAL

6.4.1 The RM shall ensure that garbage collection services are provided to all residents and businesses within the SSA.

6.4.2 Solid waste collection service shall continue to be secured through REACT.

6.4.3 The RM shall maintain the historic landfill site owned by the former Village within the requirements of the Ministry of Environment.

6.4.3.1 The RM shall be responsible to decommission the historic landfill site owned by the former Village, at the expense of the SSA, at such time as the historic landfill site may be sold to some other party, in compliance with Provincial legislation and the requirements of the Ministry of Environment.

6.5 PLUNKETT CEMETERY

6.5.1 The Plunkett Cemetery shall continue to be maintained at the same high standard as has been the historical practice of the former Village.

6.5.2 The RM shall ensure the continued existence of a funded reserve containing donations received for the ongoing maintenance of the Plunkett Cemetery.

6.6 OUTSTANDING LEGAL MATTERS

6.6.1 All outstanding legal matters will remain the financial responsibility of the SSA until the time the matters are brought to conclusion.

6.6.1.1 At the time of signing this Agreement, there are two (2) outstanding legal matters relating to tenancy of buildings owned by the former Village.

6.6.1.2 At the time of signing this Agreement, there is one (1) outstanding legal matter relating to funds regarding the Plunkett Fire Department.

6.7 COMMUNITY PROPERTY MAINTENANCE

6.7.1 The RM will maintain the streets by way of grading gravel in the spring, summer and fall months; repairing potholes and damage in the pavement; and providing and managing snow removal during winter months consistent with current practices.

6.7.2 The RM will ensure that all properties owned by the former Village will be mowed and kept in a state equal to, or better than, the current practices during spring, summer and fall months.

6.8 FIRE PROTECTION SERVICES

6.8.1 The RM will provide fire protection service to the SSA.

6.8.2 The annual levy charged by the RM for fire protection services will be charged to the SSA for those services.

6.9 STREET LIGHTS

6.9.1 The RM shall maintain the existing street lights in the former Village.

6.9.2 If there are additions to the number of street lights needed or if some of the existing street lights are no longer serving a purpose, adjustments may be made as required.

7 INTEGRATION OF ADMINISTRATION

7.1 The contract administration arrangement that exists for the Village of Plunkett will cease as of the effective date of the Minister's Order.

8 AMENDMENTS

8.1 This agreement may be amended:

8.1.1 By the Council of the RM after a two (2) year period from the effective date of the Minister's Order, when an amendment is in the best interest of the ratepayers of the former Village and the RM.

9 EFFECTIVE DATE

9.1 This agreement will come into effect on the date of inclusion as set out in the Minister's Order.

GENERAL APPLICATION PRACTICE DIRECTIVE NO. 9

SCHEDULING OF SUMMARY JUDGMENT
AND JUDICIAL REVIEW APPLICATIONS

Effective: November 1, 2019

Revised: March 1, 2022

REFERENCE: GA-PD NO. 9

1 This Practice Directive applies to all applications for summary judgment made pursuant to either Rule 7-2 or Rule 15-88 and originating applications for judicial review made pursuant to Rule 3-56(1) of *The Queen's Bench Rules*.

2 All summary judgment applications and originating applications for judicial review shall be initially made returnable in chambers on any of the days designated for that purpose.

3 The initial appearance in chambers will be for the purpose of managing the application and, after consultation with the parties, and when appropriate, ordering that a date and time for the hearing of the application be scheduled.

4 At the initial appearance, each party will be expected to speak to their readiness to proceed to a hearing, to provide their estimation as to the amount of time required to complete the hearing, identify any preliminary issues, and advise whether the matter is urgent.

5 The chambers judge at the initial appearance will manage the application, which may include determining the parties' readiness to proceed, deciding the amount of time necessary to hear the application, setting timelines when certain actions are to be taken, resolving preliminary issues and, when appropriate, ordering that a date and time for the application be scheduled to be heard.

6 The hearing date for the summary judgment or judicial review will be scheduled as soon as possible, having regard to the issues raised by the application.

7 Although, in most situations, the merits of the application will not be determined at the initial appearance, nothing in this notice is intended to prohibit the chambers judge from immediately hearing and deciding the application if, in the opinion of the chambers judge, it is appropriate to do so.

8 Rule 6-16(1) of *The Queen's Bench Rules* and General Application Practice Directive No. 7, respecting Adjournment of Chamber Proceedings, apply to the applications covered by this Practice Directive.

 - (v) the dates and details in point form of any interim court orders or agreements of the parties.
- (b) **Part 2 – Facts in Detail:** A detailed discussion of the relevant facts including:
- (i) where the parties resided, the respective roles adopted by the parties during the relationship, employment, training and educational background of the parties and parenting responsibilities towards any children of the relationship;
 - (ii) information regarding the condition, means, needs and circumstances of the parties and any anticipated changes therein;
 - (iii) having regard for the best interest factors identified in the relevant legislation, information regarding the condition, means, needs and circumstances of any children of the relationship and any anticipated changes therein;

- (iv) information regarding family property exemptions claimed, any change in the value of family property that is relevant to the matter, the position taken regarding the appropriate valuation date of family property and the basis for the value attributed where same is not agreed to; and
- (v) information regarding the most recent settlement offers and counter offers that have been exchanged between the parties.
- (c) **Part 3: Concise Summary of the evidence** in accordance with Rule 15-63(3)(b)
- (d) **Part 4 – Concise Summary of the Issues in dispute.**
- (e) **Part 5 – Argument:** In detail, set out the party’s position or argument with respect to the issues in dispute including:
- (i) a detailed discussion of the relevant facts and points of law to be argued in support of the relief being requested from the Court; and
- (ii) a List of Authorities in accordance with Rule 13-38.1
- (f) **Part 6 – Conclusion:** Set out a concise summary of the relief requested.
- (g) **Part 7 – Index to Tabs:** List sequentially the documents attached to the pre-trial brief and the tab under which they may be found.
- (h) **Schedule A:** Where division of family property is in issue, the pre trial brief Form 1 shall attach as the first tab a property schedule in the form attached to this practice directive as Schedule A. Schedule A shall include the particulars required by Rule 15-63(3)(d).
