MINISTER'S ORDER/ARRÊTÉ MINISTÉRIEL

The Municipalities Act
[subclause 61(2)(c)(iii)]

RESTRUCTURING OF THE VILLAGE OF SUCCESS

Pursuant to subclause 61(2)(c)(iii) of *The Municipalities Act* (Act), the minister may, by Order, restructure municipalities by providing for the inclusion of a municipality in any other municipality where the minister considers it to be in the public interest to do so.

IT IS HEREBY ORDERED THAT:

- 1 The Village of Success (village) shall be restructured by inclusion into the Rural Municipality of Riverside No. 168 (RM) and shall be designated as a Special Service Area (SSA) for the purpose of assigning different tax rates, applying different tax tools, and providing different service levels.
- 2 The boundary of the designated SSA is consistent with the former village boundaries and is described as:

Lands within Township 17, Range 16, West of the Third Meridian, in the Province of Saskatchewan, more specifically described as:

the portion of the south-east quarter of Section 25 lying north-west of the south-easterly limits respectively of McKay St., Parcel B and Borden St.; and

the portion of the south-west quarter Section 25 lying east of the south-westerly limit of the right-of-way and station grounds of the Canadian Pacific Railway except the portion lying east of Railway Ave. and south of McKay St.
- 3 The RM shall allocate to separate general ledger accounts all revenues collected for and on behalf of the SSA and all expenses paid for and on behalf of the SSA.
- 4 A statement of revenues and expenditures of the SSA shall be presented to the council of the RM annually and at any additional time(s) requested by council.
- 5 The terms and conditions of the original restructuring agreement entered into by the village and the RM, attached as Appendix A, are approved.
- 6 The restructuring will take effect on July 15, 2022.

IT IS FURTHER ORDERED THAT:

7 DEBRA SHAW of Swift Current, Saskatchewan, be appointed as a transition official to work with the village administrator to facilitate the transition of the village into the RM in accordance with the requirements of the Ministry of Government Relations (ministry) and this Order including:

- (a) the authority to access all municipal property, including any private premises where municipal records are located or stored, for the purpose of accessing and reviewing municipal records. "Municipal records" include any written, recorded or electronic records;
- (b) the authority to remove municipal records from any place where they are located or stored for the purpose of reviewing the records;
- (c) the authority to prepare, or assist in the preparation, of all documents and accounts as outlined by the ministry or required for the final audit of the village;
- (d) the authority to contact any ministry, crown, agency, business, or other person to request or provide information; and
- (e) the authority to act as administrator should the village administrator be unable to.

8 The appointment of Debra Shaw is in effect for the period between the signing of this Order and no later than 60 days after the effective date of the restructuring of the village.

9 Remuneration for Debra Shaw will be paid at a rate of \$60.00 per hour of work, in addition to \$0.5078 per kilometre and reimbursement of related miscellaneous expenses.

10 Remuneration for Debra Shaw shall be paid by the RM on approval of the ministry's supervising municipal advisor, after the effective date of the restructuring. The RM shall expense any payments to Debra Shaw from the SSA ledger accounts.

IT IS FURTHER ORDERED THAT:

11 WAYNE ZERFF of Regina, Saskatchewan, be appointed to adjust and settle the assets and liabilities of the village in accordance with legislation, requirements of the ministry, the restructuring agreement, and this Order, including:

- (a) the allocation of any grants, surplus funds, and reserves; and
- (b) the manner of dealing with liabilities through:
 - (i) the sale of, the disposition of, and conversion into money of sufficient assets to satisfy the liabilities of the village and pay the remuneration of the persons appointed by this Order;
 - (ii) the ability to assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the municipality, including all associated expenses and the remuneration of the persons appointed by this Order, when the realizable assets do not satisfy the liabilities pursuant to subsection 63(4) of the Act; and
 - (iii) the authority to access the village funds and bank accounts after the effective date of restructuring, transfer funds to the RM and direct the RM regarding the intended use of the funds including such uses as SSA reserve or revenue accounts.

12 The appointment of Wayne Zerff is in effect for the period between the effective date of the restructuring and when the final report to the minister has been submitted to the ministry.

13 Remuneration for Wayne Zerff will be paid at a rate of \$70.00 per hour of work, in addition to \$0.5078 per kilometre and reimbursement of related miscellaneous expenses.

14 Remuneration for Wayne Zerff shall be paid by the RM on approval of the ministry's supervising municipal advisor, after the effective date of the restructuring. The RM shall expense any payment to Wayne Zerff to the SSA ledger accounts

APPENDIX "A"

RESTRUCTURING AGREEMENT

*between the Village of Village of Success
and the
Rural Municipality of Riverside No. 168*

1 PURPOSE

1.1 This agreement has been entered into by the Village of Success (Success) and the Rural Municipality of Riverside No. 168 (RM) for the purpose of inclusion of Success into the RM.

2 RESTRUCTURING PRINCIPLES

2.1 All parties agree to respectfully work together to negotiate sustainable, long-range mutual benefits to their citizens now and in the future.

2.2 Where one municipality has concerns on a matter, the other municipality will negotiate in good faith and work cooperatively towards addressing the concern in this agreement.

3 GOVERNANCE

3.1 Upon inclusion, Success will be governed by the RM council.

3.2 The lands formerly located in the jurisdiction of Success will become part of Division 1 of the RM.

3.3 Division boundaries within the RM are subject to the Division Review Policy established by the RM in accordance with section 49.1 of *The Municipalities Act*.

3.4 All bylaws and resolutions in force in Success will continue in force for one year after the date of inclusion or until they are sooner repealed, or others are made in their place.

4 ELECTIONS

4.1 Upon inclusion, persons from Success will be subject to voter and candidate eligibility requirements for rural municipalities as set out in *The Local Government Election Act, 2015*.

5 DISPOSITION OF ASSETS

5.1 The assets and liabilities of Success shall become the assets and liabilities of the RM upon inclusion of Success.

5.2 Cash assets remaining after the settlement of the assets and liabilities of Success will be set aside for the provision of services and/or benefits within Success.

5.2.1 Cash donations received specifically for the Success sports grounds are to be allocated for the maintenance and/or restoration of the sports grounds.

5.3 All grants received by the RM in recognition of Success will be set aside for provision of services and/or benefits within Success.

6 FINANCES & TAXATION

6.1 The lands located within the former boundaries of Success will be designated as a special service area (SSA) for the purpose of assigning different tax rates, utilizing different tax tools and providing different service levels from those used in other areas of the RM.

6.2 All revenues and expenditures related to Success shall be allocated to separate accounts in the RM financial records.

6.3 The RM may impose special levies for the following purposes, if required, for a period not greater than ten years for:

6.3.1 Renewing or expanding municipal infrastructure to meet standards;

6.3.2 Remediating and reclaiming contaminated sites; and

6.3.3 Settling any liabilities.

7 SERVICE DELIVERY

The terms set out in this section may be amended by the RM council no earlier than 12 (twelve) months from the effective date of the restructuring, when an amendment is in the best interest of the ratepayers.

7.1 SEWER

7.1.1 The existing sewer system in Success will operate on a revenue-neutral basis.

7.1.2 The RM will be responsible for managing the maintenance and repairs of the sewer lines as required.

7.2 SOLID WASTE DISPOSAL

7.2.1 Garbage collection will continue on a bi-weekly basis as currently contracted.

7.2.2 Recycling collection will continue on a bi-weekly basis as currently contracted.

7.3 MUNICIPAL PROPERTY MAINTENANCE

7.3.1 The RM will maintain the streets of Success consistent with current practices.

7.3.2 The RM will be responsible for managing the maintenance of municipal property, such as grass-cutting.

7.4 FIRE PROTECTION SERVICE

7.4.1 The RM will continue to provide fire protection in Success as currently established.

7.5 STREETLIGHTS

7.5.1 The RM will continue to maintain the existing streetlights in Success.

8 ADMINISTRATION

8.1 The contracts and employment of administration and administrative staff for Success will cease as of the restructuring date ordered by the Minister.

9 LANDFILL

9.1 The RM shall decommission the Success landfill pursuant to provincial legislation and the Ministry of Environment's plan for decommissioning of waste disposal grounds.

9.2 All related expenses for decommissioning the landfill will be the financial responsibility of the SSA.

10 EFFECTIVE DATE

10.1 This agreement will come into effect on the effective date of inclusion as set out in the Minister's Order.
