RESTRUCTURING OF THE VILLAGE OF LANCER

Pursuant to section 53 of *The Municipalities Act*, the Village of Lancer has applied to restructure to be included in the Rural Municipality of Miry Creek No. 229 as a designated Special Service Area.

IT IS HEREBY ORDERED THAT:

1 The Village of Lancer (village) is restructured by inclusion of the village within the Rural Municipality of Miry Creek No. 229 (RM).

2 A Special Service Area (SSA), as described below, is hereby designated for the purpose of the assignment of different tax rates, application of different tax tools and provision of different service levels:

The following parts of Section 20, Township 21, Range 21, West of the Third Meridian:

- (a) the following portions of the north-east quarter:
 - (i) Parcel B, Plan No. 101657291, Ext. 16;
 - (ii) Parcel E, Plan No. 68SC12340, Ext. 1;
 - (iii) Parcel F, Plan No. 102080371, Ext. 0;
 - (iv) Rail Parcel, Plan No. P734, Ext. 1;
 - (v) Road Parcel, Plan No. 77SC01467, Ext 23; and
 - (vi) Road Parcel, Plan No. 77SC01467, Ext 24;
- (b) all of the portions of the north-west quarter, EXCEPT:
 - (i) Parcel D, Plan No. CS14, Ext. 5; and
 - (ii) Parcel L, Plan No. 101657279, Ext. 15.

All in the Province of Saskatchewan.

3 Properties within the village assessed under the agriculture property class, except Parcel F, Plan No. DK5560, Ext. 0, are excluded from the SSA to allow the RM to tax those parcels in the same manner as other similar properties within the RM.

4 The RM shall allocate to separate general ledger accounts all revenues collected for and on behalf of the SSA and all expenses paid for and on behalf of the SSA.

5 A statement of revenues and expenditures of the SSA shall be presented to council annually and at any additional time(s) requested by council.

6 The terms and conditions of the original restructuring agreement entered into by the village and the RM are approved as shown in the attached Appendix A. This restructuring agreement shall expire two years after the effective restructuring date.

7 The restructuring will take effect on August 1, 2022.

8 The imposition of special levies is authorized on SSA properties for a period not greater than 10 years or in the case of retiring a debt of the village, not greater than the term of the debt, for the following purposes:

- (a) renewing municipal infrastructure;
- (b) remedying and reclaiming contaminated sites; and
- (c) settling any liabilities of the village.

9 LINDA BOSER, of Swift Current, Saskatchewan, is appointed as a transition official to work with the village administrator to facilitate the transition of the village into the RM in accordance with the requirements of the Ministry of Government Relations (ministry) and this Order including:

- (a) the authority to access all village property, including any private premises where municipal records are located or stored, for the purpose of accessing and reviewing municipal records. "Municipal records" include any written, recorded or electronic records;
- (b) the authority to remove municipal records from any place where they are located or stored for the purpose of reviewing the records;
- (c) the authority to prepare or assist in the preparation of all documents and accounts as outlined by the ministry or required for the final audit on behalf of the village;
- (d) the authority to contact any ministry, Crown corporation, agency, business, or other person to request or provide information regarding the village; and
- (e) the authority to sign documents and approve payments if the administrator is unable to act.

10 The appointment of Linda Boser is in effect for the period between the signing of this Order and 30 days after the effective date of the restructuring of the village.

11 Remuneration for Linda Boser will be paid at a rate of \$60.00 per hour of work, 50.78 cents per kilometre for travel and reimbursement of related miscellaneous expenses.

12 Remuneration for Linda Boser shall be paid by the RM on approval of the ministry's supervising municipal advisor, after the effective date of the restructuring. The RM shall expense any payments to Linda Boser to the SSA ledger accounts.

13 RAYLENE PACKET, of Swift Current, Saskatchewan, be appointed to adjust and settle the assets and liabilities of the village in accordance with legislation, requirements of the ministry, the restructuring agreement, and this Order, including:

- (a) the allocation of any grants, surplus funds, and reserves; and
- (b) the manner of dealing with liabilities through:
 - (i) the sale of, the disposition of, and conversion into money of sufficient assets to satisfy the liabilities of the village and pay the remuneration of the persons appointed by this Order;
 - (ii) the ability to assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the village including all associated expenses and remuneration of the persons appointed by this Order, when the realizable assets do not satisfy the liabilities pursuant to subsection 63(4) of the Act; and
 - (iii) the authority to access the village funds and bank accounts after the effective date of restructuring, transfer funds to the RM and direct the RM regarding the intended use of the funds including such uses as SSA reserve or revenue accounts.

14 The appointment of Raylene Packet is in effect for the period between the effective date of the restructuring and the date the appointee submits a final report to the minister.

15 Remuneration for Raylene Packet will be paid at a rate of \$60.00 per hour of work, 50.78 cents per kilometre for travel and reimbursement of related miscellaneous expenses as approved by ministry officials.

16 Remuneration for Raylene Packet shall be paid by the RM on approval of the ministry's supervising municipal advisor, after the effective date of the restructuring. The RM shall expense any payment to Raylene Packet to the SSA ledger accounts.

APPENDIX A
RESTRUCTURING AGREEMENT

*between the Village of Lancer
and the
Rural Municipality of Miry Creek No. 229*

Opening Statements

(1) This agreement has been entered into by the Village of Lancer (Village) and the Rural Municipality of Miry Creek No. 229 (RM) for the purpose of the dissolution of the Village and the inclusion in the RM.

Restructuring Principles

(2) All parties agree to respectfully work together to negotiate sustainable, long-range mutual benefits to their citizens now and in the future.

(3) Where one municipality has concerns on a matter, the other municipality will negotiate in good faith and work cooperatively toward addressing the concern in this agreement.

Establishing a Special Service Area

(4) The lands within the Village (less the areas involved in the annexation process), be designated a Special Service Area (SSA) for the purposes of assigning different tax rates and/or the application of tax tools and providing different service levels.

Governance

(5) A municipal council consisting of a Reeve and 6 Councillors will continue to govern the RM.

(6) All bylaws and resolutions in force in the Village continue in force for one year after the date of inclusion or until they are sooner repealed or replaced.

(7) The RM agrees the bylaws in force in the rural municipality will become applicable in the SSA on the expiry of one year after the date of dissolution, unless sooner replaced or amended specifically identifying the designated SSA of Lancer.

Disposition of Assets

(8) The assets and liabilities of the Village shall become the assets and liabilities of the RM upon dissolution of the Village. These assets will remain in the SSA.

(9) Cash assets remaining subsequent to the settlement of the Village's assets and liabilities will be set aside for provision of services and/or benefits within the SSA.

(10) All grants received by the RM in recognition of the SSA will be set aside for provision of services and/or benefits within the SSA.

Service Delivery

(11) The RM shall provide administration for the Lancer Cemetery; however, all physical maintenance and care applications shall continue to be managed by the volunteer committee consistent with current arrangements.

(12) The RM shall provide administration for the Lancer Community Hall; however, all physical maintenance and care applications shall continue to be managed by the "Lancer Ag Society" consistent with current arrangements. The management can be amended/assisted should the Lancer Ag Society require support of the RM in the future.

(13) The RM shall provide administration for the Lancer Museum; however, all physical maintenance and care applications shall continue to be managed by the "Lancer Ag Society" consistent with current arrangements. The management can be amended/assisted should the Lancer Ag Society require support of the RM in the future.

(14) The RM and the Village agree to the closure of the Chinook Regional Library, application for closure to be finalized prior to the date of dissolution.

(15) The RM and the Village agree that the SSA office will remain open for one year. Karen Hartman will remain employed for one year to assist in any way with the transition. After one year, the RM council may amend or terminate as deemed necessary.

(16) The RM will ensure that fire protection services within the SSA are inclusive and consistent with fire protection service agreements currently established by the municipality.

(17) The RM will provide street maintenance, mowing and snow removal within the SSA consistent with current arrangements and may be modified or changed as deemed necessary.

(18) The RM will provide land fill and garbage collection services within the SSA consistent with current arrangements and may be modified or changed as deemed necessary.

(19) The RM will provide water systems operations and testing within the SSA consistent with current arrangements and may be modified or changed as deemed necessary.

(20) The RM will continue to contract Keith Nelson and Cornelius Wall for one year for mowing, snow removal, street maintenance, landfill operations, garbage collection, water system operations and testing within the boundaries of the SSA consistent with current arrangements and may amend or terminate the contract as deemed necessary.

Integration of Administration

(21) The clerk for the Village, Karen Hartman, will continue as an employee of the SSA as set out in #15.

Amendments

(22) This agreement may be amended:

(a) by the agreement of the councils which are signatories to the agreement, prior to the application being forwarded to the Minister for approval.

Effective Date

(23) This agreement will come into effect on the date of dissolution as set out in the Minister's Order.
