The Municipalities Act [sections 53, 56, 57, 59, 61, 62 and 63]

ALTERATION OF BOUNDARIES — BETWEEN THE RESORT VILLAGE OF TURTLE VIEW AND THE RURAL MUNICIPALITY OF PARKDALE NO. 498

1 Pursuant to sections 53, 56, 57, 59, and 61 of *The Municipalities Act*, the Council of the Resort Village of Turtle View has submitted an application to alter its boundaries to the Minister of Government Relations.

2 Upon consideration of the application, the Minister is of the opinion that the municipalities affected will be viable entities following the alteration of boundaries. Therefore, the undersigned hereby orders, pursuant to sections 61, 62, and 63 of *The Municipalities Act*, that:

RESTRUCTURING OF THE VILLAGE OF SCEPTRE

Pursuant to section 53 of *The Municipalities Act*, the Village of Sceptre has applied to restructure to be included in the Rural Municipality of Clinworth No. 230 as a designated Special Service Area.

IT IS HEREBY ORDERED THAT:

- 1** The Village of Sceptre (village) is restructured by inclusion of the village within the Rural Municipality of Clinworth No. 230 (RM).
- 2** A new division, namely Division 2, is created in the RM effective January 1, 2023.
- 3** The boundaries of Division 2, being consistent with the boundaries of the former village, is described as:
Township 22, Range 24, the north half of the north-east of Section 9; Rail Parcel Plan No. P993 of Section 9; all that portion of Plan No. W911 Ext 192, 193 and 194, and Plan No. N2994 Ext 1, lying in the east half of the north-west of Section 9; and the south half of the south-east of Section 16, West of the Third Meridian, in the Province of Saskatchewan.
- 4** The former village is designated as a Special Service Area (SSA) for the purpose of the assignment of different tax rates, application of different tax tools and provision of different service levels.
- 5** The RM shall allocate to separate general ledger accounts all revenues collected for and on behalf of the SSA and all expenses paid for and on behalf of the SSA.
- 6** A statement of revenues and expenditures of the SSA shall be presented to council annually and any additional time(s) requested by council.
- 7** The terms and conditions of the original restructuring agreement entered into by the village and the RM are approved as shown in the attached Appendix A.
- 8** The restructuring will take effect on January 1, 2023.
- 9** The imposition of special levies is authorized on affected properties for a period not greater than 10 years or in the case of retiring a debt of the village, not greater than the term of the debt, for the following purposes: renewing municipal infrastructure, remedying, and reclaiming contaminated sites, and settling any liabilities.
- 10** DEBRA SHAW, of Swift Current, Saskatchewan, be appointed to adjust and settle the assets and liabilities of the village in accordance with legislation, requirements of the ministry, the restructuring agreement, and this Order, including:
 - (a) the allocation of any grants, surplus funds, and reserves; and
 - (b) the manner of dealing with liabilities through:
 - (i) the sale of, the disposition of, and conversion into money of sufficient assets to satisfy the liabilities of the village and pay the remuneration of the person appointed by this Order;
 - (ii) the ability to assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the municipality, including all associated expenses and remuneration of the person appointed by this Order, when the realizable assets do not satisfy the liabilities pursuant to subsection 63(4) of the Act; and
 - (iii) the authority to access the village funds and bank accounts after the effective date of restructuring, transfer funds to the RM and direct the RM regarding the intended use of the funds including such uses as SSA reserve or revenue accounts.
- 11** The appointment of Debra Shaw is in effect for the period between the signing of this order and the date the appointee submits a final report to the minister.
- 12** Remuneration for Debra Shaw will be paid at a rate of \$60.00 per hour of work, in addition to travel at the current provincial government kilometre rate effective January 1, 2023, and reimbursement of related miscellaneous expenses.

13 Remuneration for Debra Shaw shall be paid by the RM on approval of the ministry's supervising municipal advisor, after the effective date of the restructuring. The RM shall expense any payment to Debra Shaw to the SSA ledger accounts.

IT IS FURTHER ORDERED THAT:

14 An election be held on November 9, 2022, for a councillor to represent Division 2.

15 Sherry Egeland, Administrator for the RM, is appointed as Returning Officer to conduct the election in accordance with *The Local Government Election Act, 2015*.

16 The term of office for the councillor representing Division 2 shall begin January 1, 2023 and shall expire at the time of the general election in 2026, and every four years thereafter.

IT IS FURTHER ORDERED THAT:

17 The area of the RM shall be confirmed as follows:

Townships 19, 20, 21, and 22, Ranges 22, 23 and 24;

Township 23, Ranges 22 and 23;

Township 23, Range 24, all that portion lying to the right of the left bank of the South Saskatchewan River;

Township 24, Ranges 22, 23 and 24, all those portions lying to the right of the left bank of the South Saskatchewan River;

All West of the Third Meridian, in the Province of Saskatchewan.

The six divisions shall be confirmed as follows:

Township 19, Range 22;

Township 19, Range 23, Sections 1 to 3, 10 to 15, 22 to 27 and 34 to 36;

Township 20, Range 22; and

APPENDIX A**RESTRUCTURING AGREEMENT**

between the Village of Sceptre

and the

Rural Municipality of Clinworth No. 230

Opening Statements

1 This agreement has been entered into by the Village of Sceptre (Village) and the Rural Municipality of Clinworth No. 230 (RM) for the purpose of inclusion.

Restructuring Principles

2 All parties agree to respectfully work together to negotiate sustainable, long-range mutual benefits to their citizens now and in the future.

3 Where one municipality has concerns on a matter, the other municipality will negotiate in good faith and work cooperatively toward addressing the concern in this agreement.

Establishment Of Special Service Area

4 The lands within the former Village shall be designated as a Special Service Area (SSA) for the purposes of assigning different tax rates and/or application of tax tools and providing different service levels.

5 The designated Special Service Area shall be within the boundaries of the former Village.

6 The RM shall allocate all revenues collected from and on behalf of the SSA to special area ledger accounts; and all expenses of the SSA shall be allocated to and paid from special service area ledger accounts.

Establishment Of New Division

7 Upon inclusion, the lands of the former Village shall be considered a separate division within the boundaries of the RM, to be known as Division 2, and, as such, a councillor shall be elected to represent that division. The municipal costs of the election process are a charge on the RM as a whole.

Governance

8 A municipal council consisting of a Reeve and six (6) Councillors will govern the RM.

9 All bylaws and resolutions in force in the Village continue in force in the SSA for one year after the date of inclusion or until they are sooner repealed or others are made in their place.

Disposition Of Assets

10 The assets and liabilities of the Village shall become the assets and liabilities of the RM upon inclusion of the Village.

11 Cash assets remaining subsequent to settlement of the Village assets and liabilities will be set aside for provision of services and or benefits within the SSA.

12 All grants received by the RM in recognition of the former Village will be set aside for provision of services and or benefits within the SSA.

Service Delivery

13 That the Great Sandhills Museum & Interpretive Centre be maintained and controlled by the Great Sandhills Historical Society, consistent with current arrangements.

14 That the Sceptre Memorial Gardens Cemetery be maintained and controlled by the Sceptre Memorial Gardens Cemetery Association, consistent with current arrangements.

15 The RM will ensure that fire protection services are inclusive and consistent with fire protection service agreements currently established by the Village.

16 The RM shall ensure existing street lights remain within the SSA.

17 The RM will continue to maintain existing water and sewer services and issue water and sewer bills bi-monthly to SSA consumers.

18 The RM will provide street maintenance, snow removal, mowing/spraying services within the SSA boundaries, as well as any other duties to ensure the upkeep of the SSA.

19 The RM will provide garbage collection and utility services using existing contractors, consistent with current arrangements, within the SSA.

Integration Of Administration

20 The administrator for the Village will continue as an employee of the RM.

Amendments

21 This agreement may be amended:

(a) by the agreement of the councils which are signatories to the agreement, prior to the application being forwarded to the minister for approval; and/or

(b) by the council of the RM after a two-year period from the effective date of the Minister's Order, when an amendment is in the best interest of the ratepayers of the SSA and the RM.

Effective Date

22 This agreement will come into effect on the date of inclusion as set out in the Minister's Order.
