MINISTER'S ORDER/ARRÊTÉ MINISTÉRIEL

The Municipalities Act [section 53]

RESTRUCTURING OF THE VILLAGE OF ARRAN

Pursuant to section 53 of *The Municipalities Act*, the Village of Arran has applied to restructure to be included in the Rural Municipality of Livingston No. 331 as a designated Special Service Area.

IT IS HEREBY ORDERED THAT:

- 1 The Village of Arran (Village) is restructured by inclusion of the village within the Rural Municipality of Livingston No. 331 (RM).
- 2 The former Village is designated as a Special Service Area (SSA) for the purpose of the assignment of different tax rates, application of different tax tools and provision of different service levels.

3 The boundaries of the designated SSA is consistent with the boundaries of the former Village and is described as:

The west half of the south-west quarter of Section 6, Township 34, Range 30 and the east half of the south-east quarter of Section 1, Township 34, Range 31, all West of the First Meridian, in the Province of Saskatchewan.

4 The RM shall allocate to separate general ledger accounts all revenues collected for and on behalf of the SSA and all expenses paid for and on behalf of the SSA.

5 A statement of revenues and expenditures of the SSA shall be presented to council annually and any additional time(s) requested by council.

6 The terms and conditions of the original restructuring agreement entered into by the Village and the RM are approved as shown in the attached Appendix A.

7 The restructuring will take effect on January 1, 2023.

8 The imposition of special levies is authorized on affected properties for a period not greater than 10 years or in the case of retiring a debt of the Village, not greater than the term of the debt, for the following purposes: renewing municipal infrastructure, remedying and reclaiming contaminated sites, and settling any liabilities.

9 BARRY HVIDSTON, of Canora, Saskatchewan, be appointed to adjust and settle the assets and liabilities of the Village in accordance with legislation, requirements of the ministry, the restructuring agreement, and this Order, including:

(a) the allocation of any grants, surplus funds, and reserves; and

(b) the manner of dealing with liabilities through:

(i) the sale of, the disposition of, and conversion into money of sufficient assets to satisfy the liabilities of the village and pay the remuneration of the person appointed by this Order;

(ii) the ability to assess, levy, collect and enforce payment of any amount that may be required to satisfy the liabilities of the municipality, including all associated expenses and remuneration of the person appointed by this Order, when the realizable assets do not satisfy the liabilities pursuant to subsection 63(4) of the Act; and

(iii) the authority to access the village funds and bank accounts after the effective date of restructuring, transfer funds to the RM and direct the RM regarding the intended use of the funds including such uses as SSA reserve or revenue accounts.

10 The appointment of Barry Hvidston is in effect for the period between the signing of this Order and the date the appointee submits a final Report to the Minister.

11 Remuneration for Barry Hvidston will be paid at a rate of \$60.00 per hour of work, in addition to travel at the current provincial government kilometre rate effective January 1, 2023, and reimbursement of related miscellaneous expenses.

12 Remuneration for Barry Hvidston shall be paid by the RM on approval of the ministry's supervising municipal advisor, after the effective date of the restructuring. The RM shall expense any payment to Barry Hvidston to the SSA ledger accounts.

APPENDIX "A"

RESTRUCTURING AGREEMENT

*between the Village of Arran
and the
Rural Municipality of Livingston No. 331*

OPENING STATEMENTS

1 This agreement has been entered into by the Village of Arran (Village) and the Rural Municipality of Livingston No. 331 (RM) for the purpose of inclusion.

RESTRUCTURING PRINCIPLES

2 All parties agree to respectfully work together to negotiate sustainable, long-range mutual benefits to their citizens now and in the future.

3 Where one municipality has concerns on a matter, the other municipality will negotiate in good faith and work cooperatively toward addressing the concern in this agreement.

ESTABLISHMENT OF SPECIAL SERVICE AREA

4 The lands within the former Village shall be designated as a Special Service Area (SSA) for the purposes of assigning different tax rates and/or application of tax tools and providing different service levels.

5 The designated SSA shall be within the boundaries of the former Village.

GOVERNANCE

6 A municipal council consisting of a Reeve and four (4) Councillors will govern the RM.

7 The SSA will become part of Division 2 of the RM.

8 Persons within the SSA will be subject to voter and candidate eligibility requirements for rural municipalities as set out in *The Local Government Elections Act, 2015*.

9 All bylaws and resolutions in force in the Village continue in force for one year after the date of inclusion or until they are sooner repealed or others are made in their place.

10 All revenues and expenditures related to the SSA shall be allocated to separate accounts in the RM financial records.

DISPOSITION OF ASSETS

11 The assets and liabilities of the Village shall become the assets and liabilities of the RM upon inclusion of the Village.

12 Cash assets remaining subsequent to settlement of the Village assets and liabilities will be set aside for provision of services and/or benefits within the former Village.

13 All grants received by the RM in recognition of the former Village will be set aside for provision of services and/or benefits within the former Village.

SERVICE DELIVERY

14 The RM shall decommission the Village landfill as required pursuant to provincial legislation and the Ministry of Environment for decommissioning of waste disposal grounds.

15 The RM will provide street maintenance, snow removal, and mowing/spraying services within the SSA boundaries, as well as any other duties to ensure the upkeep of the SSA.

16 The RM shall ensure existing streetlights remain within the SSA.

17 The RM will ensure that fire protection services are inclusive and consistent with fire protection service agreements currently established by the municipality.

18 The RM will continue to maintain existing water services and will pursue a qualified person to maintain existing water services if no person has been obtained prior to the Minister's Order.

INTEGRATION OF ADMINISTRATION

19 The contracts for administration and administrative staff that exist for the Village will cease as of the restructuring date ordered by the minister.

AMENDMENTS

20 This agreement may be amended by the agreement of the councils which are signatories to the agreement, prior to the application being forwarded to the minister for approval.

EFFECTIVE DATE

21 This agreement will be effective for a two (2) year period after the date of inclusion as set out in the Minister's Order.
