(a) all that area lying south and west of a line commencing at the southern intersection of the north-west and north-east quarter section lines, thence northerly to the northern boundary of said Quarter Sections, thence westerly along the northern boundary of Poplar Ave. and of Lot 1 to its intersection with the northern-most limit of Lot 2, in Block 8, thence south-westerly along the north-western boundary of said Lot to its intersection with the south-western boundary of Lot 4, in Block 9, thence south-easterly along said boundary and of Poplar Ave. as described in Registered Plan No. CG934, to its intersection with the north-western boundary of the Canadian National Railway as described in Plan No. BF3042, thence south-westerly along said boundary to its intersection with the western boundary of said Quarter Section.

DESIGNATION OF FACILITY

WHEREAS section 2-9 of *The Provincial Health Authority Act* provides that:

“2-9 The minister may designate all or part of a facility operated by a health services entity or any other person as one of the prescribed categories of facilities”.

AND WHEREAS clause 2(1)(g.1) of *The Facility Designation Regulations* provides that:

“(g.1) “**mental health services**” means the provision of care to an individual for the purposes of promoting, preserving and restoring the mental health of an individual to an optimal level, including assessment, treatment, health education and consultation;”

AND WHEREAS section 8 of *The Facility Designation Regulations* provides that:

“8 If a facility or part of a facility is designated as a regional hospital:

- (a) it must provide to in-patients and out-patients:
- (i) medical services;
 - (ii) basic radiography and laboratory services;
 - (iii) fluoroscopy and computerized tomography diagnostic services;
 - (iv) emergency stabilization services;
 - (v) observation and assessment services;
 - (vi) convalescent care and palliative care;
 - (vii) surgical services;
 - (viii) obstetrical services;

- (ix) intensive care services; and
 - (x) specialty medical services in the areas of internal medicine, general surgery, obstetrics and gynaecology; and
- (b) it may provide any of the following:
- (i) specialty medical services in areas including, but not limited to, orthopaedics, ophthalmology, urology and otolaryngology;
 - (ii) rehabilitation services;
 - (iii) services mentioned in clauses 5(f) to (o)".

AND WHEREAS section 12.2 of *The Facility Designation Regulations* provides that:

"12.2 If a facility or part of a facility is designated as a mental health centre, it must provide the following to in-patients and out-patients:

- (a) physician services;
- (b) specialty physician services in the area of psychiatry;
- (c) registered nurse, registered psychiatric nurse or nurse practitioner services;
- (d) mental health services;
- (e) emergency stabilization services;
- (f) observation and assessment services;
- (g) rehabilitation services; and
- (h) one or more of the services mentioned in clauses 5(g) to (o)".

AND WHEREAS subsection 13(1) of *The Facility Designation Regulations* provides that:

"13(1) The minister shall publish in Part I of *The Saskatchewan Gazette*, a list of all facilities or parts of facilities that have been designated, their titles, the categories or subcategories to which they have been designated and their effective dates of designation".

AND WHEREAS it is in the public interest to temporarily designate a portion of the Cypress Regional Hospital as a "mental health centre" to avoid service disruption of the provision of mental health services due to a staff shortage.

NOW THEREFORE, I, Paul Merriman, Minister of Health, pursuant to section 2-9 of *The Provincial Health Authority Act*, orders that:

- 1 The part of the facility listed in Column B of the attached Schedule "A" is designated as a mental health centre.
- 2 The designation of the Medical/Surgical Unit number four located on the second floor in the Cypress Regional Hospital, located at 2004 Saskatchewan Dr., Swift Current SK S9H 5M8 is in effect from December 21, 2022 until January 6, 2023. On January 7, 2023, its designation is repealed.

(c) by repealing subsection 6(2) and substituting the following:

“(2) Registration as a graduate practical nurse is only available for the period of time commencing on completion of the recognized practical nurse education program or the determination by council that the educational program completed by the applicant is equivalent to a recognized practical nurse education program and ending on the successful completion of the prescribed examination or on a fourth failure of that examination”.
