Overview of Travel and Objectives

SK has been one of Canada's top exporters to India for the past decade – with exports valued at C\$1.4 billion in 2022. It is important that the Government of Saskatchewan maintains relationships and conducts missions to India regularly.

- India is a key buyer of our agricultural products – in 2022, the province was India's largest supplier of lentils;
- India is a key buyer of SK potash – in 2022, SK was India's largest supplier of potash and is a potential growth market due to the country's growing need for food; and
- as India works to expand its nuclear energy program, SK is well-positioned to meet the country's demand for uranium.

This was Premier Moe's second mission to India. Mission objectives included:

- promoting the SK-India trade relationship by showcasing SK strengths and opportunities in agriculture, mining, innovation and energy and highlighting the opportunity for SK to be a stable, sustainable and trusted partner of India in energy and food security;
- supporting SK uranium, and potash and ag tech companies in efforts to grow their exports to India;
- showcasing SK as a preferred destination for Indian investment; and
- advancing SK's post-secondary and innovation linkages.

Travel Activity

While in Mumbai, Premier Moe met with:

- The Consul General of Canada in Mumbai;
- Mahindra and Mahindra Ltd.;
- India's Department of Atomic Energy and India Rare Earth Limited (IREL); and
- Other current or potential Indian investors in SK.

While in Chandigarh, Premier Moe met with:

- The Consul General of Canada in Chandigarh; and,
- The Chief Minister of the State of Haryana.

He also participated in:

- A Confederation of Indian Industry (CII) Ag Tech Roundtable with the Minister of Agriculture of Haryana State and a live demonstration of Clean Seed Capital Group's SMART Seeder agricultural technology;
- A Memorandum of Understanding (MOU) Signing Ceremony with Saskatchewan Polytechnic and three Indian post-secondary institutions (Shoolini University, IREU Education and Shri Vishwakarma Skill University);
- A University of Saskatchewan Roundtable on the connection between food, water, and energy and MOU signing between the University of Saskatchewan and one Indian post-secondary institution (Chandigarh University); and
- An interview with the Indian Express.
