Overview of Travel and Objectives

In 2022, for the first time in provincial history, Saskatchewan's trade to Mexico has exceeded \$1 billion. Key agricultural exports include canola products such as seed, oil and meal, as well as non-durum wheat, malt, lentils and livestock genetics.

Mission objectives included:

- Promoting Saskatchewan as a committed and reliable supplier of safe, high-quality, and the most sustainably produced agricultural products in the world;
- Reinforcing established relationships with key buyers of agricultural commodities;
- Profiling investment opportunities in Saskatchewan's value-added sector; and
- Working with United States (U.S.) and Mexican States on market access issues and areas of mutual interest for our agriculture and food industries, such as foreign animal disease outbreaks, and the exceptional sustainability of our agriculture production.
