Overview of Travel and Objectives

The objective of the Minister's travel was to attend the follow up Federal, Provincial and Territorial meeting of the Ministers Responsible for Justice and Public Safety. The meeting was called in response to the Premiers' letter to Prime Minister Trudeau regarding the strengthening of Canada's bail system and the call for an urgent Ministerial meeting on the issue.

Travel Activity

Minister Eyre participated in the FPT meetings on Bail Reform along with her provincial/territorial counterparts to call on the federal government to reform Canada's bail system. Minister Eyre also attended bi-lateral meetings with colleagues from Alberta, Manitoba and Ontario.

While at the FPTs Minister Eyre highlighted the impacts of federal bill C-75 and put forward potential amendments to the Criminal Code to hold repeat violent offenders accountable, improve public safety, and restore Canadians' confidence in the justice system. Minister Eyre proposed creating reverse onuses on bail for repeat violent offenders, strengthening language around the importance of community safety; and requiring judges to provide written consideration of the impacts to public safety when releasing violent offenders on bail. Following the meetings, federal Justice Minister David Lametti announced a commitment to "move forward quickly on targeted reforms to the Criminal Code on bail."

While in Ottawa, the Minister also met with Members of Parliament from Saskatchewan to provide an overview of, and discuss the Saskatchewan First Act.
