Overview of Travel and Objectives

The Energy and Mines Ministers' Conference (EMMC) is an annual gathering of federal, provincial and territorial ministers responsible for energy and mining portfolios. At these meetings, ministers discuss shared priorities for collaborative action to advance energy and mining development across the country.

Travel Activity:

The meeting provided an opportunity for the Ministers and Deputies to discuss issues facing the energy and mining sectors and provided a format for discussion of various issues facing provinces and regions. These discussions including indigenous community engagement, improving regulatory systems, Carbon Capture, Utilization and Storage (CCUS) injection sites, biofuels production, wind energy and critical minerals.

Ministers also discussed Canada's competitiveness in the face of the U.S. Inflation Reduction Act (IRA), and the means put in place or to be put in place to respond to it, as well as the participation and contribution of the provinces and territories in the dialogues to which Canada is taking part with its international partners.

In addition to the EMMC sessions, Minister Reiter and his delegation also had side meetings with:
