Overview of Travel and Objectives

The World Petroleum Congress event is an international conference that is held every three years. It presents important networking and bilateral engagement opportunities to meet with key decision makers in the energy and financial sectors. The event includes over 15,000 visitors from over 100 countries with many high-profile attendees, including heads of state, senior executives, policy makers, service and technology providers and various other key players within the industry.

Travel Activity:

The Minister participated in the Energy Roundtable event, which included an opportunity to share the Government of Saskatchewan's perspective, followed by a panel discussion moderated by Gary Mar, CEO, Canada West Foundation. The panel's other speakers included the Honorable Brian Jean, Alberta Minister of Energy and Minerals and the Honorable Andrew Parsons, Minister of Industry, Energy and Technology - Newfoundland and Labrador.

Minister Reiter was also part of an expert panel at an event held by Alberta Counsel. Among the strategic issues the panel addressed were the vision and associated impacts for the future of the energy industry, the net zero agenda for 2050, as well as opportunities in clean and renewable energy. Other speakers on the six-person panel were the Honorable Brian Jean, Alberta Minister of Energy and Minerals, Chief Raymond Powder, Brad Herald, a senior adviser at the Canadian Association of Petroleum Producers (CAPP), Adam Sweet of Clean Prosperity, and Adam Waterous, CEO of the Waterous Energy Fund.

The Minister attended multiple sessions as an audience member including an expert panel of the Indigenous role in achieving net zero by 2050; an expert panel on energy transition, climate change, technology, and geopolitics; and an expert panel on energy security.
