Overview of Travel and Objectives

Minister Skoropad traveled to Ontario to participate in the annual in-person meeting of the Canadian Council of Ministers of the Environment (CCME). CCME is the primary, minister-led intergovernmental forum for collective action on environmental issues of national and international interest, composed of the environment ministers from the federal, provincial, and territorial governments.

Travel Activity:

Prior to the formal meeting, Minister participated in a meeting with representatives from industry and environmental organizations. The discussion centered around opportunities for harmonization and innovation in the waste sector, such as promoting a circular plastics economy.

Minister also participated in a meeting with several of the National Indigenous Organizations and representatives from Ontario First Nations and Métis communities to discuss ways to improve collaboration on water issues. The discussion touched on opportunities for collaboration across all orders of government and the importance of meaningful engagement.

As part of the CCME meeting Minister:

- participated in discussions that reflected on the above-noted meetings as well as discussions regarding managing plastic waste and the Ministers considered the types of information that might be helpful to share across jurisdictions (i.e., accepted material lists) to support harmonization;
- participated in conversations on climate adaptation and innovation, including: federal funding; allowing jurisdictions the flexibility to determine tools and strategies; and support for industry innovation.

The meeting concluded with a joint communiqué, which was supported by Saskatchewan.
