## **Overview of Travel and Objectives:**

The objective of the Minister's travel was to attend the Federal-Provincial-Territorial (FPT) Ministers' meeting on Human Rights in Halifax, Nova Scotia.

### **Travel Activity:**

Minister Eyre joined ministers of Ontario, British Columbia, Nova Scotia and the Yukon (several other ministers participated virtually), as well as the federal Minister of Families, Children and Social Development, Karina Gould, at this FPT meeting for Human Rights, co-hosted by Nova Scotia and the Government of Canada.

Discussions included human rights in the digital age, including protecting children from Online harm, as well as issues surrounding entrenching international treaties in domestic law and the ongoing importance and role of the *Charter of Rights and Freedoms*.

Minister Eyre highlighted Saskatchewan's human rights record on reconciliation, domestic violence and human trafficking prevention initiatives, disability rights, and the province's promotion of multiculturalism and immigration, including the protection of over 4,000 people fleeing the war in Ukraine.

Saskatchewan was selected to co-chair and host the next FPT forum on Human Rights in 2025.
