Overview of Travel and Objectives

The objectives of the meeting were:

- to provide an update on infrastructure policy/program priorities, continued challenges, and new developments since the November 2022 FPT Ministers of Infrastructure meeting;
- to discuss progress on multilateral engagement/collaboration on infrastructure and future opportunities;
- to reflect on priorities outlined by Ministers and identify opportunities for continued collaboration on shared infrastructure objectives;
- to hear from experts on the challenges and opportunities for increasing the use of low carbon materials and design in the Canadian construction sector; and
- to promote awareness of the Canadian Table for Harmonized Construction Codes Policy and renewal of the National Model Construction Codes.

Travel Activity

Minister meetings included:

- Federal update
 - identified directions from Budget 2023, including around the Canada Infrastructure Bank (CIB);
 - provided an update on INFC priorities (eg permanent public transportation, housing resilience, national infrastructure assessment, etc.); and
 - discussed opportunities for ongoing collaboration, key issues and next steps.
- CIB: The Path Forward
 - provided an overview of the CIB's renewed vision following Budget 2023;
 - promoted awareness of new priorities of the CIB, including investments in clean power, green infrastructure, and loans to support Indigenous equity stakes in major infrastructure projects; and
 - discussed potential implications for provinces and territories.
- Strengthening Outcomes from Infrastructure Investments
 - considered opportunities to align infrastructure planning and development to achieve greater outcomes from infrastructure investments (eg transit-oriented development)
 - examined provincial-territorial challenges and opportunities to linking planning and building of community infrastructure; and
 - discussed key take-aways and opportunities.

Deputy Minister meetings included:

- Low Carbon Infrastructure Solutions
 - Heard from experts regarding the opportunities presented by Buy Clean policies;
 - Considered the climate impacts of the construction industry, with an emphasis on low-carbon materials and design; and

- Discussed challenges and opportunities for Canadian jurisdictions to reduce embodied carbon and create opportunities for Canadian manufacturers and materials suppliers through Buy Clean policies.
- Renewal of the National Model Construction Codes Governance
 - Increased awareness of the Canadian Table for Harmonized Construction Codes Policy and its role in setting direction for the development of the National Model Construction Codes; and
 - Reviewed recent changes to the national code-making governance model and introduce the National Research Council and the Canadian Table for Harmonized Construction Codes Policy as decision makers in national codes development.
- Priorities for Coming Year
 - Reviewed key messages from Ministers' discussion and expert session;
 - Reflected on and assessed opportunities to advance key priorities through ongoing collaboration at the infrastructure tables; and
 - Identified opportunities for provincial-territorial engagement toward the fall update.
