Overview of Travel and Objectives

Minister Makowsky attended the Council of Ministers Responsible for Housing meetings in Ottawa, ON where he served as Co-Chair. Minister Makowsky provided support in advancing Saskatchewan's interest at the national level with regards to housing need and priorities specific to housing as well as complex issues such as homelessness.

Travel Activity:

While in Ottawa, Minister Makowsky met with other provincial Council of Ministers Responsible for Housing to discuss important housing issues facing Canadians including the complex challenges around supply, affordability, and Canada's growing issue of homelessness.

Ministers discussed how to better align initiatives and programs while recognizing that addressing housing issues is not a one size fits all approach, and flexibility is required in program design and delivery to meet local needs. As partners in housing, Ministers committed to looking more closely at how they can better meet Canadians' needs through shared investments and increased flexibility within housing initiatives and agreements.

While in Ottawa, Ministers met with national Indigenous leaders and representatives to discuss shared housing priorities, including how governments can support Indigenous-led housing solutions to address the unique housing needs of Indigenous people.

Minister Makowsky also met with the federal Housing Minister to discuss pressures on shelters and transitional housing in Saskatchewan as well as fair federal funding commitments.
