GENERAL INFORMATION

The Medical Services Branch prepares practitioner profiles on a fiscal year basis. The fiscal year begins April 1 and ends March 31 the following year.

- a) **Quarterly** fiscal profiles are available on the following basis:
 - a. First April to June, inclusive
 - b. Second July to September, inclusive
 - c. Third October to December, inclusive
 - d. Fourth January to March, inclusive
- b) An **annual** fiscal profile is available and covers a twelve-month period from April of one year to March of the following year. There is no annual profile based on the calendar year.

PROFILE COSTS (GST incl.)

Profile rates are as follows:

QUARTERLY PROFILE	\$5 per quarter
ANNUAL PROFILE	\$20

A complete set of fiscal profiles (four quarterly and an annual) may be obtained for a fee of \$40.00. **A reduced offer for profiles ordered and prepaid prior to June 1st of that fiscal year is \$30.00.** When ordering a complete set, a cheque for \$40.00 should accompany the form. **Cheques should be made payable to the MINISTER OF FINANCE.** For profile requests received after June 1st the regular rates of \$5.00 per quarter and \$20.00 for an annual will apply.
