*(sections 2 and 18)*

BYLAWS TO CONTROL BURNING —  
 VILLAGE OF GOODSOIL

A Bylaw of the Village of Goodsoil, in the Province of Saskatchewan to regulate the burning of refuse and other materials within the boundaries of the Village of Goodsoil.

The Council of the Village of Goodsoil in the Province of Saskatchewan, under the authority of the Saskatchewan *Clean Air Act*, Section 18, hereby enacts as follows:

**BYLAW 11/2001**

1 All terms and expressions used in this bylaw shall have the respective meanings as in sections 2 and 18 of *The Clean Air Act* and section 11 of *The Clean Air Regulations*.

2 No person shall cause or permit to be caused the open burning of trash, refuse, garbage, used oil, industrial waste or any other material or waste in an open fire or an incinerator in a manner that causes air pollution within the boundaries of the Village of Goodsoil.

3 No person shall cause or permit to be caused the burning of trash, refuse, garbage, used oil, industrial waste or any other waste material in a manner or in an incinerator other than that approved by the Department of Environment.

4(1) No person shall cause or permit to be caused the burning of any solid, liquid or gaseous fuel in any outdoor fuel burning equipment for the purpose of domestic, commercial and institutional comfort heating.

(2) No person shall cause or permit to be caused the burning of used oil in any indoor or outdoor fuel burning equipment.

5 Sections 2, 3 and 4 of this bylaw do not apply to:

(a) a camp fire or outdoor fireplace used for recreational purposes;

(b) an outdoor fire using charcoal, processed coal or coke for cooking purposes;

(c) the burning of brush for the purpose of clearing land for cultivation or for a roadway, railway line, pipeline or any other right of way; and

(d) a fire for the purpose of burning weeds, the prevention or control of fires or the training of persons for fire fighting, if the fire is specifically authorized or required pursuant to any Act, Act of Parliament or Bylaw of a Municipality.

6 Approval from the Council of the Village of Goodsoil is required prior to causing a fire for the purposes outlined in clauses 5(c) and (d). In an emergency situation approval may be obtained from the local fire or police authorities.

7 Any person who violates or fails to comply with any of the provisions of this bylaw is guilty of an offense and liable on summary conviction to the penalties set out in *The Clean Air Act*.

8 This bylaw shall not come into force until after approval by the Minister of Environment, and ninety days after the date of publication of this bylaw in *The Beaver River Banner* and *The Saskatchewan Gazette*, and at that time Bylaw 4/91 will be considered repealed.
