



Application for Approved Reclamation Technology

July 2025

In accordance with the Reclamation Technology Standard, I hereby apply for approval to construct a new or upgraded and existing storage facility.

A. Application Requirements

To apply for an evaluation of a technology under the Reclamation Technology Standard, an applicant shall send a concise package of information and data to the ministry together with a signed copy of the application form. The ministry will evaluate the technology by reviewing the information and data submitted by the applicant. The application package will be subject to technical review and evaluation in the light of relevant science and technology. The application information submitted shall be specific to the technology and shall include the following:

- a) a detailed description of the technology;
- b) the types and quantities of environmental media to be treated;
- c) the scientific basis for the technology, including but not limited to peer reviewed publications;
- d) any testing protocols relating to evolution of the technology;
- e) any designed process flow diagrams;
- f) any required equipment and design;
- g) the range of operating conditions;
- h) any emissions and byproducts released to environment by the technology;
- i) details of the chemical formulation of any chemical used with the technology; and
- j) a discussion on the suitability and applicability of the technology in Saskatchewan.

VERIFIED TECHNOLOGIES FROM OTHER JURISDICTIONS

In the event that the technology in question has been approved by another jurisdiction, the applicant must submit

sufficient information to demonstrate that the technology is approved for its intended purpose by another competent jurisdiction. In addition, the proponent must provide sufficient information to demonstrate that the application of the technology will be effective for its intended use in Saskatchewan.

How do I submit the application? You can submit this application to the Ministry of Environment using our online services or by mailing a hard copy.

In the portal you can apply for and receive permission, fill out forms and submit documents online, review documents, and track your interactions with the ministry.
