

Individual Farm Land Ownership Statutory Declaration Form

The *Saskatchewan Farm Security Act* (Act) establishes that only Canadian citizens, permanent residents, or Canadian-owned entities (corporations that are 100 per cent Canadian owned and are not publicly traded) can hold an interest in more than 10 acres of Saskatchewan farm land. The Farm Land Security Board (FLSB) monitors farm land transactions to ensure each one complies with the ownership restrictions in the Act.

The FLSB has legislative authority to demand that a statutory declaration be completed by any person or entity that holds an interest in Saskatchewan farm land. These declarations provide the FLSB with important information about land holdings. It is an offence to not complete a declaration if one is requested.

Each individual owner or interest holder must complete a form.
