

Saskatchewan Protective Services Medal *Nomination Form*



Established in 2003, the Saskatchewan Protective Services Medal recognizes exemplary long service for individuals working in a direct capacity to protect people and/or property, and supervisory personnel in the public service sectors who ensure the safety, security and protection of Saskatchewan citizens. These individuals set high standards and strive for excellence in their duties so everyone in Saskatchewan can live safe and secure lives. The medal honours protective services providers and focuses attention on the efforts and work of police, fire and emergency professionals, and others working in the field of safety and security.

Eligibility: Individuals must be actively employed in an eligible organization within one year of the nomination. Nominees must also be personnel with 25 years of service in Saskatchewan and actively employed in one of the eligible agencies on or after January 1, 2003, who have law enforcement powers, or work in safety services and professions whose work is directly related to the safety, security and protection of people and/or property.
