

## PROMOTER LICENCE APPLICATION for Professional Combative Sport Events

This application package contains information on obtaining a one (1) year licence as a promoter for professional combative sport events in the Province of Saskatchewan.

**\* For the purposes of this form, the term “business” may include, but is not limited to a corporation, partnership, sole proprietorship, unincorporated business or other recognized entity.**

**Step 1** Complete the Promoter Licence Application in full, ensuring all required signatures are present.

**Step 2** In addition to the completed Promoter Licence Application, please submit to the Athletics Commission of Saskatchewan (the Commission) the following:

- ☐ Information acceptable to the Commission showing that the applicant has a satisfactory credit rating;
- ☐ Information acceptable to the Commission to establish that the applicant can reasonably be expected to be competent and financially responsible in promoting a professional contest or exhibition;
- ☐ If the applicant is a corporation, a copy of its most recent annual return;
- ☐ A Criminal Record Check that:
  - is satisfactory to the Commission
  - was completed by a police service not more than 30 days prior to the date on which the Criminal Record Check is provided to the Commission
  - discloses to the Commission whether the applicant has been charged with, discharged from or convicted pursuant to the Criminal Code or Controlled Drugs and Substance Act (Canada) and is:
    - If the applicant is an individual, with respect to the applicant;
    - If the applicant of a business, with respect to each partner, officer or director.
- ☐ Clear photocopies of two (2) pieces of personal identification, one which has your photo and is government-issued (example: passport, driver's licence);
- ☐ A list of the applicant's experience as a promoter, including a list of the locations and dates of past events promoted by the applicant;
- ☐ A non-refundable application fee in the amount of \$100 (Canadian funds). Please make all cheques payable to the Minister of Finance.
