## About

This release implemented 47 items and included an enhancement to the Well License Application process to eliminate duplicate review/approval, and an enhancement to the Comminglement Applications; which have been split into two separate applications. A new billable option has been introduced and new columns have been added to the Daily Well Bulletin. A description has been added to the Disposition Rental Invoice for leases within a DHOA where an active EOR Project is present. As well, various enhancements and fixes to known defects have been implemented to the Well and Facility Infrastructure, Petroleum Tenure and Invoice Modules.

## What's changed?

The highlights of what's changed in IRIS as a result of this release are noted below.

**Note:** Whether a user has access to the functionality or enhancements outlined in these *Release Notes* depends on the individual's security access and assigned permissions sets.

### Well and Facility Infrastructure Functionality

- The Well Licence Application process has been enhanced to eliminate duplicate review and approval from Agriculture and Environment.
  - This change will impact licences that have already been reviewed and approved by Agriculture and Environment, are denied or cancelled, and subsequently resubmitted. If the resubmission is within one year and there are no surface lease changes from the original application, the application does not require a second review and the approval and the obligations and surface lease will be applied to the new submission. - The IRIS Release 6.01 includes an enhancement to Comminglement Applications, which are now split into two separate applications in IRIS – one for oil/gas and one for disposal/other. At the Application>Reservoir>Commingling-Oil/Gas and Commingling-Disposal/Other, the IRIS User will be able to apply for Commingling-Oil/Gas which will have a new structured format similar to the Well Licensing application, while Commingling-Disposal/Other is in same format as it was before the change. - A new billable obligation has been introduced to allow the Ministry to request an additional drilling survey plan, or as drilled survey plan after initial licensing, as well as the new Attachment document type “Survey Plan”. Once the obligation is fulfilled, Client Support will receive a work item so that they are aware of the submission and can verify that the submission has provided a proper revised survey plan.
- New columns have been added to the Daily Well Bulletin report to indicate if a licence is a resubmission of a cancelled or a denied well licence, and to provide the original licence/application number. The “Resubmission” field will display a “Y” or “N” corresponding to the selection that was chosen in the application. The Original Licence number field will display the licence number that was in the “Original Licence Number field” entered in the application.
- Searching incidents by incident status functionality will be working properly for Industry users.
- An enhancement has been implemented which will allow Ministry Users of IRIS, with applicable permissions, to create Land Areas for Projects when creating a new Project. The Land Areas will be designated “Project Area” in the Project information.

The Ministry User can also:

- Create a Project Area of land locations on existing Projects
- Edit and add Project Area histories
- Search for Projects in IRIS using Land Location in the Search criteria

### **Petroleum Tenure Module**

The Disposition Rental Invoice for leases within a DHOA where an active EOR Project is present, will now have a description of “Rental – EOR Project” rather than just “Rental”. This change is meant to enhance the existing disposition rental invoice to identify the number of hectares being invoiced the EOR Project rental rate.

Changes were made to IRIS permission sets as follows:
