## About

This release implemented 27 items and included enhancements to the Well Licence Application process that will eliminate duplicate review and approval, and correct an obligation issue. New Incident obligation functionality has been added which will enable the Ministry to assess non-compliance penalties as per the *Oil and Gas Conservation Regulations, 2012*, Part III, Table 1 Submission Penalties. Improved search functionality has been developed for parameters and a new parameter added to the Inspection Report. As well, various enhancements and fixes to known defects have been implemented to the Well and Facility Infrastructure, Petroleum Tenure and Invoice Modules.

## What's changed?

The highlights of what's changed in IRIS as a result of this release are noted below.

**Note:** Whether a user has access to the functionality or enhancements outlined in these *Release Notes* depends on the individual's security access and assigned permissions sets.

### Well and Facility Infrastructure Functionality

- The Well Licence Application process has been enhanced to eliminate duplicate review and approval, from Agriculture and Environment, for applications declared to be in a PAD Well Set. In instances where an existing PAD Well Set has an approved licence that has been previously reviewed and approved by Agriculture and Environment the approvals, Obligations and Surface lease will be applied to the subsequent approved licences in the PAD Well Set. - Industry will now be able to select the "High Priority" parameter in the Advanced Inspection Search and view any inspections marked as "High Priority" by the Ministry. The "Only High Priority Inspection" parameter has been added as a selection option in the Inspection Report query build screen and the new column "High Priority?" has been created in the report.
- New functionality has been implemented to correct an issue where obligations issued by the Ministries of Environment and Agriculture were not carried over to Well Licence application resubmissions.
- New Functionality has been introduced for the Ministry to provide subsequent warnings to BAs after Inspection Items have initially become overdue.

- New Incident obligation functionality will enable the Ministry to assess non-compliance penalties to Industry in regards to failure to provide 90-day “Detailed Incident Information” within the allotted time frame. This incident obligation penalty will be assessed as per the *Oil and Gas Conservation Regulations, 2012*, Part III, Table 1 Submission Penalties. The obligation will be shadow billed for a period of three months prior to actual billing. Please see the [Tip](#) for more details.
