CHAPTER 52

An Act respecting certain Consequential Amendments
to certain Acts resulting from the enactment of
The Saskatchewan Farm Security Act

(Assented to June 29, 1988)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of
Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Saskatchewan Farm Security Consequential Amendment Act*.

2 Clause 41(4)(b) of *The Agricultural Implements Act* is amended by striking out “subsection (1) of section 5 of *The Exemptions Act*” and substituting “subsection 70(1) of *The Saskatchewan Farm Security Act*”.

3 Section 45 of *The Condominium Property Act* is amended by adding “and clause 66(h) of *The Saskatchewan Farm Security Act*,” after “Act”.

4 Subsection 16(1) of *The Creditors’ Relief Act* is amended by adding “or Part V of *The Saskatchewan Farm Security Act*” after “*Act*”.

6 Subsection 32(2) of *The Enforcement of Maintenance Orders Act* is amended by striking out “does” and substituting “and section 66 of *The Saskatchewan Farm Security Act* do”.

7 Section 26 of *The Executions Act* is amended by adding “or Part V of *The Saskatchewan Farm Security Act*” after “*Act*”:

(a) in subsection (2); and

(b) in subsection (3).

New section 1.2

(2) The following section is added after section 1.1:

Non-application

“1.2 This Act does not apply to farmers as defined in Part V of *The Saskatchewan Farm Security Act*”.

(3) Section 2 is amended:

- (a) by repealing paragraph (1)4;
- (b) by repealing paragraphs (1)8 and 9; and
- (c) by repealing subsection (2).

Section 3 amended

(4) Subsections 3(2) and (3) are repealed.

Section 12 amended

(2) Section 12 is amended:

- (a) by adding “or section 71 of *The Saskatchewan Farm Security Act*, as the case may be” after “Act”; and
- (b) by adding “or section 71” after “said section 6”.

10 Section 39 of *The Housing and Special-care Homes Act* is amended by striking out “*The Farm Security Act*” and substituting “*The Saskatchewan Farm Security Act*”.

11 Subsection 180(3) of *The Land Titles Act* is amended by striking out “*The Exemptions Act*” wherever it appears and in such case substituting “*The Exemptions Act* or Part V of *The Saskatchewan Farm Security Act*”.

(2) The following section is added after section 1:

Non-application

“1.1 This Act does not apply where *The Saskatchewan Farm Security Act* applies”.

(3) Subsection 8(2) is repealed and the following substituted:

“(2) Nothing in this section affects a mortgagee’s right to recover costs as between party and party in an action under the mortgage instituted in a court of competent jurisdiction, or to recover the costs of distress allowed by *The Distress Act*, nor does anything in this section affect, alter or vary any right that, on the first day of May, 1937, a mortgagee had to reasonable and necessary costs and expenses of collecting the rents or profits of the mortgaged land where the land was leased to a person other than the owner”.

(6) Subsection 15(1) is amended by striking out “in the case of leases of farm lands a one-third share crop rental shall be deemed a reasonable yearly rental and”.

(b) by repealing clause (2)(b).

Section 19 amended

(8) Clause 19(b) is amended by repealing subclauses:

(a) (i) to (iii); and
