- Develop and maintain positive and productive business relationships with key stakeholders in the region, and across the Government of Saskatchewan;
- Support key marketing initiatives that promote Saskatchewan; and,
- Advocate for Saskatchewan's priorities using your exceptional diplomacy and communication skills, and by exhibiting a high-degree of personal accountability.

To be successful in the role, you will need to understand the competitive advantage of doing business in Saskatchewan and have extensive knowledge of international business practices to deliver on key outcomes that include:

- Developing, delivering and evaluating promotion, investment attraction, international relations and advocacy services;
- Identifying business opportunities and gathering relevant market intelligence;
- Providing advice on international business and cultural practices;
- Developing strategic plans to assist Saskatchewan stakeholders to gain access to trade and investment opportunities; and,
- Building networks to advance Saskatchewan's interests in the region.

Ideal Candidate

You will be:

- A team player, able to both lead and collaborate, with a reputation for integrity, and a focus on service excellence and innovation in their work.
- A strategic thinker who is able to clearly communicate plans and influence others to generate enthusiasm and commitment.
- A strong communicator who is able to identify and develop relationships with key stakeholders.
