About

IRIS Version 7.6 Release implemented 29 items along with a new Structured Reclamation Declaration Application. Altered Well Flag functionality has been enhanced to improve date ranges. A notification has been added to Non-Routine Abandonment authorizations. An enhancement to the subject line of IRIS Invoice Notifications will make it easier for industry to track their invoices. The Lease Continuance Preliminary and Final Report Search screen has been modified to provide better searchability. A new Security Report was added to further assist SAs to manage user permissions. As well, various enhancements and fixes to known defects have been implemented to the Infrastructure, Petroleum Tenure and Invoice Modules.

What's changed?

The highlights of what's changed in IRIS as a result of this release are noted below.

Note: Whether a user has access to the functionality or enhancements outlined in these 7.5 *Release Notes* depends on the individual's security access and assigned permissions sets.

Infrastructure Functionality

- Altered Well Flag functionality has been implemented to allow for *Effective From* dates in the past, and to allow end-dating of the *Effective To* date.
- Notifications for *Authorization Expiring* and *Authorization Expired* have been added on Non-Routine Abandonment authorizations. Please see related Tip here for further information.
- A new structured Reclamation Declaration Application has been implemented. The application will
 allow the environmental practitioner to submit a request to the ministry, on behalf of the licensee,
 to temporarily reduce the deemed reclamation liability based on reclamation work that has been
 completed at the site prior to completing the final Acknowledgement of Reclamation (AOR)


Revenue and Billing Module

An enhancement has been made to IRIS Invoice Notifications. This enhancement changes the subject line that is generated for the notification by adding specific details and an invoice number, making it easier for industry to track their invoices. Additionally, the message displayed with the invoice was improved. Please see below for before and after images of the changes.


The **new** subject line will reflect the format of:

BA ID BA NAME – IRIS Invoice Notification – invoice number

E.g. 00000 Ministry of Energy and Resources – IRIS Invoice Notification – Axxxxxx Note that each type of invoice has its own respective letter to begin the invoice numbers

Also, a reminder to those who need these notifications to sign up within IRIS. To do this, Instructions are as follows:

On IRIS, go to > Business Apps > IRIS > Support > Notification > Notification Preferences > Scroll to the bottom of page and click on

> Scroll down to 'Organization Subscribers' > Billing > IRIS Invoice Notifications > Select notification preferences (see below)



Petroleum Tenure Module

The Lease Continuance Preliminary and Final Report Search screen has been modified to provide better searchability. The Lease Continuance Report Search screen can be found with the following steps:

- 1. Log into IRIS.
- Navigate through the IRIS main menu to Reports > Tenure Disposition > Lease Continuance >
 Preliminary and Final.

Users can continue to leave all fields empty and click the **Search** button to query all of their BAID's Preliminary and Final Lease Continuance reports. To query your BAID's Lease Continuance reports generated within a specific timeframe, select dates from the **Continuance Run Date From** and the **Continuance Run Date To** fields. The results are returned and can be sorted by clicking on the column header.

As before, to locate all Preliminary and Final reports for a specific disposition, enter the disposition number/identifier into the **Disposition ID** field and click on the **Search** button.

Security Module

A new Security Report has been developed to further assist SAs to manage user permissions. The *Historical Report for Permission Sets Removed & Assigned* provides historical data for Permission Set history by user between a date range.
