# Ministry of Agriculture Public Trust Survey

Insightrix Research, Omnibus Survey, May 2021



# Executive Summary

The Ministry of Agriculture has participated in omnibus polling since 2013 to gain insight into the public's perception of the agriculture and agri-food industry, to assess the impact of efforts to build public trust and to establish benchmarks for the future initiatives.

The 2021 Public Trust Survey, conducted by Insightrix Research in May, asked 801 Saskatchewan residents for their perspectives on 10 questions. The results continue to show Saskatchewan residents have a positive perception of Saskatchewan agriculture. For example, 89 per cent respondents "agreed" or "strongly agreed" to the statement *I have a positive perception of Saskatchewan agriculture*. Furthermore, 91 per cent of respondents agree food produced in Saskatchewan is safe.

The survey continues to show high positive responses to questions related to the humane treatment of animals, environmental stewardship, innovation in agriculture and food safety. Questions gauging whether the government's regulations for agriculture protect the interests of the public and the transparency of the agriculture sector's communications of practices, show lower positive perception compared to other questions. Sixty-two per cent of respondents agreed that government's agriculture regulations protect the interest of the public and 54 per cent agree the agriculture sector communicates transparently. This highlights the importance of informing consumers on Saskatchewan's robust regulatory framework. It also demonstrates consumers want the agriculture industry to communicate their practices with greater transparency. When asked what the agriculture industry could do to be more transparent, almost 50 per cent of respondents indicated the industry honestly communicate about their practices.

Access to credible information about agriculture proved to be an important driver of public trust. When analyzed against the other nine public trust questions, agreeing that one had access to credible information about agriculture, made respondents more likely to agree with the other questions. This shows that access to credible information is more important than demographics and ought to remain a pivotal focus of the industry.

The demographic analysis provides additional insight. The 18-34 age group is more likely to disagree, strongly disagree or choose "Don't Know" to a number of questions. Similarly, female respondents are more likely to disagree, strongly disagree or choose "Don't Know" to the majority of the questions. These results seem to suggest the biggest gains to increasing public trust will be achieved by focusing on the 18-34 age group and female residents of the province. Similar to 2020, the respondents from the south region of the province were again more likely to agree to the majority of the questions.

When compared to national polling done by the Canadian Centre for Food Integrity (CCFI), Saskatchewan residents show greater support for the industry. Statements focused on the overall

perception of the industry, humane treatment of livestock, environmental stewardship, food safety, among others, were more favourable among Saskatchewan residents when compared to the broader Canadian population.

The results of this survey will help inform the agriculture sector in relation to policies, programs and initiatives, with the goal of building society's trust in, and acceptance of, modern food production.


## 1. I have a positive perception of Saskatchewan agriculture.


## 2. Livestock in Saskatchewan are treated humanely.

#### **Notable**

- The statement used in 2016-2018 was "I believe livestock in Saskatchewan are treated humanely."
- Respondents from the south region of the province are more likely to strongly agree compared to the north, Regina and Saskatoon regions.
- Respondents from the 18-34 age group are more likely to disagree or strongly disagree, whereas the 35-54 age group are more likely to strongly agree and the 55+ age group are more likely to agree.
- Women are more likely to choose "Don't Know" than men (14 per cent).




## 3. Saskatchewan farmers and ranchers take care of the environment.

#### **Notable**

- The statement used from 2013 to 2015 was "Saskatchewan farmers and ranchers are good stewards of the land, sustaining the environment for future generations."
- Respondents from the 18-34 age group are more likely to disagree or strongly disagree, whereas the 35-54 age group are more likely to strongly agree and the 55+ age group are more likely to agree.
- Men are more likely to disagree than women.
- The respondents from the south region are more likely to agree compared to the north, Regina and Saskatoon regions.
- Respondents with university education are more likely to disagree compared to other education groups.




# 4. Government's agriculture regulations protect the interests of the public.

#### 2021 Results<sup>2</sup>

#### **Notable**

- The question was first asked in 2019 as "Government's agriculture regulations protect the interests of the public."
- A significant portion of respondents (25 per cent, up four per cent from 2020) don't know if the government's regulations for the agriculture industry protect the interests of the public.
- Respondents from the 18-34 age group are more likely to select "Don't Know" or are less likely to agree compared to other age groups.


# 5. Farmers and ranchers follow government and industry rules and regulations.

- Respondents from the south region of the province is more likely to agree compared to the north, Regina and Saskatoon regions.




## 7. I have access to credible information about agriculture and food.




## 9. Food produced in Saskatchewan is safe.

- The question was first asked in 2016 and 2017 as "I believe all food in the grocery stores is safe" and in 2018 as "I believe food produced by Saskatchewan farmers and ranchers are safe."
- Respondents from the 18-34 age group are more likely to choose "Don't Know" or disagree than other age groups; whereas the 35-54 is more likely to agree.
- Men are more likely to strongly agree than women.



# 10. The agriculture sector transparently communicates about their practices.


