Overview of Travel and Objectives

The United States was Saskatchewan's largest agri-food export market in 2021, with sales of \$4.3 billion. Key agricultural exports include canola products, oats, non-durum wheat, live cattle and peas. Saskatchewan exported over \$354 million to Colorado and Minnesota in 2021.

This was Minister Marit's first official trade mission to the United States. Mission objectives included:

- Promoting Saskatchewan as a committed and reliable supplier of safe, high-quality agricultural products;
- Reinforcing and continuing to strengthen established relationships with key stakeholders and buyers of agricultural commodities;
- Promoting investment and expanding relationships with long-standing partners in the United States;
- Profiling Saskatchewan's research industry and innovation capabilities and collaborative opportunities in the province's value-added sector; and,
- Discussing and working together on matters and areas of mutual interest for our agriculture and food industries, such as the importance of trade with the Canada-United States-Mexico Agreement (CUSMA).

Travel Activity

While in Colorado and Minnesota, the Minister met with:

- The Consul General of Canada in Denver and the Consul General of Canada in Minneapolis;
- The Commissioner of the Minnesota Department of Agriculture;
- The Chancellor of Colorado State University;
- Senior representatives from the Colorado Farm Bureau;
- Senior executives from grain, oilseed, pulse, and plant-based protein companies looking to do business in Saskatchewan;
- A global ingredient/plant equipment manufacturer;
- A global food processing company; and
- Key representatives from the livestock sector including: Minnesota Cattlemen's Association and Minnesota Beef Council.

The Minister also attended the Colorado Cattlemen's Association Annual Convention and provided remarks to key cattle stakeholders at the Ranching Legacy Symposium.
