## **Overview of Travel and Objectives**

---

This conference was the first in-person meeting in three years amongst the federal, provincial and territorial ministers of the Environment. This meeting was an opportunity to have yearly meetings amongst Ministers once again, for Ministers to share best practices across their jurisdictions along with discussing ideas and solutions to improve the environment across the country.

### **Travel Activity**

During the meetings, the Ministers:

- Expressed concern over federal policies that label plastics as toxic;
- Shared different approaches to respond to a changing climate;
- Discussed the importance of affordability for households while reducing greenhouse gas emissions;
- Met Indigenous leaders to discuss climate change; and
- Discussed lower-carbon solutions, such as small modular reactors, carbon capture and storage, wind and solar.
