

Pre-Approval of Saskatchewan Early Childhood Educator Qualifications Application – Applicants Living Internationally

About this Application Form: The Pre-Approval of Saskatchewan Early Childhood Educator Qualifications Application is for individuals who do not live in Canada. The Ministry of Education completes pre-approval of qualification assessments for international applicants with an Invitation to Apply from the Saskatchewan Immigrant Nominee Program (SINP), a Letter of Receipt of Application from SINP, or a conditional job offer from a regulated child care centre operator. The Ministry of Education does not issue Early Childhood Educator (ECE) certificates to applicants who live internationally.



Please read the *Saskatchewan Early Childhood Educator Certification Guide* before completing this application form. The guide provides helpful information about eligibility for ECE certification in Saskatchewan, as well as detailed application steps for international applicants applying for pre-approval of qualifications.
