## **CHAPTER 17**

An Act to repeal miscellaneous obsolete Public and Private Statutes  
and to make certain consequential amendments

(Assented to May 14, 2014)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of  
Saskatchewan, enacts as follows:
