REVISED REGULATIONS OF SASKATCHEWAN

SASKATCHEWAN REGULATIONS 98/2015

The Traffic Safety Act

Section 287

Order in Council 538/2015, dated November 3, 2015

(Filed November 4, 2015)

Title

1 These regulations may be cited as *The Commercial Vehicle and Drivers (Record-Keeping) Amendment Regulations, 2015*.

R.R.S. c.H-3.1 Reg 22, section 2 amended

2 Clause 2(d) of *The Commercial Vehicle and Drivers (Record-Keeping) Regulations* is repealed and the following substituted:

“(d) ‘commercial vehicle’ means any of the following vehicles:

(i) a vehicle that:

- (A) is registered in Class A, C or D or that would be registered in Class A, C or D if that vehicle was registered in Saskatchewan; and
- (B) has a registered gross vehicle weight of 5 000 kilograms or greater;

(ii) a vehicle that:

- (A) is registered in Class LV or that would be registered in Class LV if that vehicle was registered in Saskatchewan;
- (B) is being used for a commercial use and is not a farm vehicle; and
- (C) has a registered gross vehicle weight of:
 - (I) 11 794 kilograms or greater; or
 - (II) if operated outside Saskatchewan, 5 000 kilograms or greater;

(iii) a vehicle that:

- (A) is registered in Class PB, PC or PS or that would be registered in Class PB, PC or PS if that vehicle was registered in Saskatchewan; and
- (B) has a seating capacity, according to the manufacturer of that vehicle, of more than 10 persons, including the driver;

but does not include an emergency vehicle as defined in *The Vehicle Equipment Regulations, 1987* or a funeral vehicle”.

Coming into force

3 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

SASKATCHEWAN REGULATIONS 99/2015*The Traffic Safety Act*

Section 287

Order in Council 539/2015, dated November 3, 2015

(Filed November 4, 2015)

Title

1 These regulations may be cited as *The Registration Exemption and Reciprocity (Jurisdictions) Amendment Regulations, 2015*.

R.R.S. c.T-18.1 Reg 13 amended

2 *The Registration Exemption and Reciprocity Regulations, 2014* are amended in the manner set forth in these regulations.

Section 2 amended

3 **Clause 2(2)(d) is amended by striking out “vehicle” and substituting “motor vehicle”.**

New section 3

4 **Section 3 is repealed and the following substituted:**

“Reciprocity with other jurisdictions

3(1) The minister may enter into agreements with any jurisdiction whereby:

(a) persons ordinarily resident in Saskatchewan are granted certain privileges in that jurisdiction in connection with the use of a vehicle; and

(b) persons ordinarily resident in that jurisdiction are granted similar privileges in Saskatchewan.

(2) If the minister has entered into a reciprocal agreement with a jurisdiction pursuant to subsection (1), a person mentioned in clause (1)(b) may register a commercial vehicle or public service vehicle that is registered in that jurisdiction, or obtain a registration permit to operate that vehicle, in Saskatchewan on payment of the fees set out in, and subject to the terms of, the agreement if that person:

(a) is ordinarily resident in that jurisdiction; and

(b) is the owner of the commercial vehicle or the public service vehicle.

(3) If a person who is eligible pursuant to subsection (2) registers that person's commercial vehicle or public service vehicle pursuant to a reciprocal agreement, the vehicle:

(a) is to be registered subject only to the terms of the agreement between the minister and the jurisdiction; and

(b) is exempted from the provisions of subsection 57(1) of the Act”.

Section 5 amended

5 **Section 5 is amended by striking out “vehicle that is registered in Manitoba” and substituting “commercial vehicle or public service vehicle that is registered in Manitoba”.**

Section 8 repealed

6 Section 8 is repealed.

New sections 9 to 12

7 Sections 9 to 12 are repealed and the following substituted:

“CAVR

9 If a province is a signatory to the CAVR and extends the privileges set out in that agreement to persons ordinarily resident in Saskatchewan, a person ordinarily resident in that province is exempted from the provisions of subsection 57(1) of the Act if the person:

- (a) registers that person’s vehicle pursuant to the CAVR; and
- (b) observes the terms and conditions of the CAVR.

“IRP

10 If a jurisdiction is a signatory to an agreement pursuant to the IRP and extends the privileges set out in that agreement to persons ordinarily resident in Saskatchewan, a person who is ordinarily resident in that jurisdiction is exempted from the provisions of subsection 57(1) of the Act if the person:

- (a) registers that person’s vehicle pursuant to the IRP;
- (b) observes the terms and conditions of the IRP agreed to by Saskatchewan and that person’s jurisdiction; and
- (c) pays a prorated fee calculated in accordance with the IRP.

“Trailer, semi-trailer exemption

11 If a person is ordinarily resident in another jurisdiction and is the owner of a trailer or semi-trailer that has been registered in that jurisdiction, that person is exempted from the provisions of subsection 57(1) of the Act.

“General exemption

12 If a person operates in Saskatchewan a commercial or public service vehicle that is registered in another jurisdiction and that is not being used for the transportation of passengers, goods or permanently mounted equipment, that person is exempted from the provisions of subsection 57(1) of the Act”.

Coming into force

8 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

SASKATCHEWAN REGULATIONS 100/2015*The Wildlife Habitat Protection Act*

Section 3

Order in Council 540/2015, dated November 3, 2015

(Filed November 4, 2015)

Title

1 These regulations may be cited as *The Wildlife Habitat and Ecological Lands Designation Amendment Regulations, 2015 (No. 7)*.

R.R.S. c.W-13.2 Reg 4, Appendix amended

2 *The Wildlife Habitat and Ecological Lands Designation Regulations* are amended in the Appendix:

(a) by repealing item 294 and substituting the following:

“294 All those lands in Township 40, in Range 10, west of the Second Meridian, described as follows:

- (a) the west half and north-east quarter of Section 2;
- (b) that portion of the south-west quarter of Section 3 covered by the waters of Englund Lake;
- (c) the north-west quarter of Section 7;
- (d) the south half and north-east quarter of Section 11;
- (e) the north-west quarter of Section 29”;

(b) by repealing item 295 and substituting the following:

“295 All those lands in Township 41, in Range 10, west of the Second Meridian, that are Crown owned and described as follows:

- (a) the north half of Section 1;
- (b) the north-east quarter of Section 2”;

(c) by repealing item 432 and substituting the following:

“432 All those lands in Township 5, in Range 17, west of the Second Meridian, described as follows:

- (a) the west half of Section 5;
- (b) the south half and north-east quarter of Section 8;
- (c) the north-west quarter of Section 10;
- (d) the south-east quarter of Section 18”;

(d) by repealing item 522 and substituting the following:

“522 The north half of Section 29, in Township 19, in Range 22, west of the Second Meridian”;

(e) by repealing item 557;

(f) by repealing item 558 and substituting the following:

“558 That portion of the south-west quarter of Section 13 lying to the right of the right bank of the South Saskatchewan River, in Township 48, in Range 23, west of the Second Meridian”;

(g) by repealing item 591 and substituting the following:

“591 All those lands in Township 53, in Range 24, west of the Second Meridian, described as follows:

- (a) the south-west quarter of Section 12;
- (b) Section 14;
- (c) the east half of Section 15;
- (d) the north-west quarter of Section 29”;

(h) by repealing item 600;

(i) by repealing item 702 and substituting the following:

“702 All those lands in Township 3, in Range 30, west of the Second Meridian, described as follows:

- (a) the south-west quarter of Section 3;
- (b) the west half and south-east quarter of Section 4;
- (c) that portion of Section 24 that is Crown owned;
- (d) that portion of Section 25 that is Crown owned;
- (e) that portion of the north-east quarter of Section 26 that is Crown owned;
- (f) that portion of Section 36 that is Crown owned”;

(j) by repealing item 791 and substituting the following:

“791 All those lands in Township 47, in Range 4, west of the Third Meridian, described as follows:

- (a) the south-east quarter of Section 4;
- (b) the north-west quarter of Section 5;
- (c) the south-west quarter of Section 8;
- (d) the south half and north-west quarter of Section 9;
- (e) the north half and south-west quarter of Section 10;
- (f) the north-west quarter of Section 14;
- (g) the west half of Section 16;

- (h) the east half of Section 17;
- (i) the south-east quarter of Section 20;
- (j) the south half and north-east quarter of Section 21;
- (k) the north-east quarter of Section 29;
- (l) that portion of the north-east quarter of Section 36 that is Crown owned”;

(k) by repealing item 914 and substituting the following:

“914 All those lands in Township 48, in Range 8, west of the Third Meridian, described as follows:

- (a) the north-west quarter of Section 4;
- (b) the north half of Section 9;
- (c) Section 11;
- (d) the north half and south-west quarter of Section 19;
- (e) the north-west and south-east quarters of Section 21;
- (f) that portion of Section 24 not covered by the waters of Iroquois Lake;
- (g) that portion of Legal Subdivisions 3, 5 and 6 of Section 25 not covered by the waters of Iroquois Lake;
- (h) the south-west quarter of Section 26;
- (i) the north-west quarter of Section 28;
- (j) Section 29;
- (k) the east half of Section 30;
- (l) the south half of Section 31;
- (m) the south-east quarter of Section 35”;

(l) by repealing item 947 and substituting the following:

“947 All those lands in Township 50, in Range 9, west of the Third Meridian, described as follows:

- (a) the north half of Section 1;
- (b) Section 2;
- (c) the south-west quarter of Section 7;
- (d) the south-east quarter of Section 9;
- (e) Section 11;

- (f) the north-east and south-west quarters of Section 12;
- (g) the north half of Section 13;
- (h) the south half of Section 24;
- (i) Legal Subdivisions 12 and 13 of Section 35;
- (j) the north-east quarter of Section 36”;

(m) by repealing item 1069 and substituting the following:

“1069 All those lands in Township 51, in Range 13, west of the Third Meridian, described as follows:

- (a) the north-west quarter of Section 8;
- (b) the north-west quarter of Section 35”;

(n) by repealing item 1191 and substituting the following:

“1191 All those lands in Township 52, in Range 17, west of the Third Meridian, described as follows:

- (a) that portion of the south half of Section 4 that is Crown owned;
- (b) the north half of Section 29;
- (c) the south-east quarter of Section 35;
- (d) the west half of Section 36”;

(o) by repealing item 1464 and substituting the following:

“1464 All those lands in Township 23, in Range 25, west of the Third Meridian, described as follows:

- (a) the north half of Section 5;
- (b) Section 6;
- (c) Section 7;
- (d) the north half of Section 9;
- (e) the north half of Section 16;
- (f) that portion of the west half of Section 17 lying to the right of the right bank of the South Saskatchewan River;
- (g) that portion of the north half of Section 18 lying to the left of the left bank of the South Saskatchewan River and that portion of the south-east quarter of Section 18 lying to the right of the right bank of the South Saskatchewan River;
- (h) the north-west quarter of Section 19;
- (i) that portion of the south half of Section 21 lying to the right of the right bank of the South Saskatchewan River;

- (j) the south-east quarter of Section 22;
- (k) the north half and south-west quarter of Section 23;
- (l) that portion of Section 25 lying to the right of the right bank of the South Saskatchewan River;
- (m) the north half of Section 27 and that portion of the south-east quarter of Section 27 lying to the left of the left bank of the South Saskatchewan River;
- (n) the south half of Section 28;
- (o) the south-west quarter of Section 29;
- (p) the south-west quarter of Section 30”; **and**

(p) by repealing item 1526 and substituting the following:

“1526 All those lands in Township 23, in Range 27, west of the Third Meridian, described as follows:

- (a) the south half and north-west quarter of Section 2;
- (b) the north half of Section 3;
- (c) that portion of the north half of Section 4 not covered by the waters of the South Saskatchewan River;
- (d) the south-east quarter of Section 5 and that portion of the north half of Section 5 not covered by the waters of the South Saskatchewan River;
- (e) the south-west quarter of Section 6;
- (f) those portions of the south half and north-west quarter of Section 7 not covered by the waters of the South Saskatchewan River;
- (g) that portion of the south-west quarter of Section 8 lying to the right of the right bank of the South Saskatchewan River;
- (h) that portion of the north-west quarter of Section 9 not covered by the waters of the South Saskatchewan River;
- (i) those portions of the west half and south-east quarter of Section 10 lying to the right of the right bank of the South Saskatchewan River;
- (j) the north-west quarter of Section 14;
- (k) that portion of the west half of Section 15 not covered by the waters of the South Saskatchewan River;
- (l) Section 16;
- (m) the south half of Section 18;

- (n) Section 21;
- (o) that portion of the north-west quarter of Section 22 not covered by the waters of the South Saskatchewan River;
- (p) the south-west quarter of Section 23 and that portion of the north half of Section 23 lying to the left of the left bank of the South Saskatchewan River;
- (q) that portion of Section 25 not covered by the waters of the South Saskatchewan River;
- (r) the north-east quarter of Section 26;
- (s) that portion of the west half of Section 27 lying to the left of the left bank of the South Saskatchewan River;
- (t) the south-east quarter of Section 28;
- (u) the north half of Section 33;
- (v) the south half and north-west quarter of Section 34;
- (w) the south half and north-east quarter of Section 35;
- (x) Section 36”.

Coming into force
