## CHAPTER 28

### An Act to amend the Statute Law

(Assented to November 30, 2016)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

**Short title**

**1** This Act may be cited as *The Statute Law Amendment Act, 2016*.
